- Supervise the process of periodic screening of hospitals/consultants/laboratories for enlistment/removal, revision of rates and ensure clearance of their bills
- Participate as member of Medical Review Committee and constitute Medical Board for examining medical conditions of patients and report its finding for management's action
- Develop SOPs for smooth operations of medical services function and ensure its effective implementation in addition to exercising financial and monetary oversight
- Perform any other work, which may be assigned by the senior management including attendance of patients as and when referred
