Kindly refer to FBR letter No.5(1)CSTRO/FBR/2016 dated 23rd August, 2016, on the subject noted above.

- The refund issued by FBR is not regulated by the Finance 2. Division. FBR issues refunds on the basis of its determination that the amounts so involved are not part of the Federal Consolidated Fund. The amount of refund involved is returned to the concerned business house/entity through a cheque issued by FBR without recourse to any budgetary provision. The timings of payment of refunds are exclusively determined by FBR and so is the validity period of the cheques issued. This position has been endorsed by the AGPR as well.
- In view of the above, no instructions are required to be issued by 3. Finance Division to either AGPR or CGA since FBR is competent to issue Finance Division, therefore, instructions. endorses FBR's No.5(1)CSTRO/FBR/2016 dated 22nd August, 2016 addressed to State Bank of Pakistan.
