## **FREIGHT SUBSIDY ON LIVE SEAFOOD**

Live seafood fetch very high prices in international markets as compared to frozen products. To encourage export of live seafood, Government in the Trade Policy for the year 2009-10 has extended freight subsidy @ 25% on air shipment of live seafood.

### **Terms & Conditions**

- i. The exporters of live seafood would submit their claims to TDAP through their banks.
- ii. In case of advance payment, the exporters would be required to submit the claim within 30 days otherwise the duration for filing the claims would be 90 days from the date of realization of export Sales proceed.
- iii. Exporters would submit the following documents alongwith their claims:
  - ◆ Form E – original
  - ◆ GD – original
  - ◆ Customs verified Invoice – original
  - ◆ Bank certificate / Undertaking
  - ◆ Export Proceed Realization certificate
  - ◆ Copy of Health Certificated issued by Marine Fisheries Department, Government of Pakistan.
- iv. Reimbursement would be made on Remittances instead of Actual Exports.
- v. All by air shipments of Live Seafood from 1st September, 2009 will qualify for the facility.
- vi. Payments would be made through National Bank of Pakistan, FTC branch, Karachi after the scrutiny of the claims by a Scrutiny Committee constituted by TDAP for this purpose.
