ORDER

Islamabad, the 22nd Dec., 2008

S.R.O. 1299(I)/2008.—In pursuance of entry 7 of item 29A of Schedule II to the Rules of Business, 1973, the Federal Government is pleased to direct that the following amendments shall be made in its Notification No. S.R.O. 1045(I)/2008, dated the 19th September, 2008, namely:—

In the aforesaid Order,—

(a) in paragraph 2,—

- (i) in sub-paragraph (1), for the words, letters and brackets "procured PTA through State Bank of Pakistan (SBP)" the words, letters, brackets, full stop and comma "procured or imported PTA through

State Bank of Pakistan (SBP). The exporters using imported PTA in the manufacture of exported goods will not be paid duty drawback on the PTA. However, they would continue to be paid normal duty drawback on their inputs other than PTA component" shall be substituted;

- (ii) after sub-paragraph (2), the following new sub-paragraphs shall be inserted, namely:-

"(2A) Application for compensatory support pertaining to imported PTA during the pervious month shall be filed by the unit with the authorized bank or its authorized dealer up to 7th of the every succeeding month in the form as set out in Annexure-IA to this Order as per the following formula:-

Amount refundable on account of 7.5% import tariff on PTA.	=	Sum of custom value of PTA imported per GD's x 7.5%

The application along with the copies of Good Declaration showing the import of PTA and payment of customs duty thereon will be subject to the verification by the State Bank of Pakistan from the concerned Collectorate of Customs.

(2B) The importer shall provide to the State Bank of Pakistan a comprehensive statement of PTA imported during the previous month as set out in Annexure-IA. While claiming the repayment of customs-duty, the importer shall act with due diligence to ensure that claim is based on facts.

(2C) The authorized dealers shall submit claims to the State Bank of Pakistan within three working days."

- (iii) in sub-paragraph (4), after the word "support" at the end, the words "and the company shall attach a copy of certificate of incorporation with SECP with the claim" shall be added;
- (iv) in sub-paragraph (5), after the word "support" the words "for locally procured PTA" shall be inserted;
- (v) in sub-paragraph (6), for the words, figure and letters "up to 11:00 a.m" the words, figures and letters "from 09:00 a.m to 01:30 p.m" shall be substituted;

- (vi) in sub-paragraph (8), after the word "invoices" at the end, the words and commas "or, as the case may be, the Goods Declaration" shall be added;
- (vii) in sub-paragraph (9), after the word "invoice", the oblique and words "/Goods Declaration" shall be inserted;
- (viii) in sub-paragraph (10), after the word "invoice", the words and commas "or, as the case may be, the Goods Declaration" shall be inserted; and
- (ix) in sub-paragraph (11), after the word "Dealers", the words "under intimation to the respective firm" shall be inserted;
- (x) in sub-paragraph (13), after the word "sales", the words "or import" shall be inserted; and
- (xi) after the sub-paragraph (13), the following new sub-paragraph shall be added namely:—

“(14) All stakeholders shall avoid overwriting or cutting on sales tax invoice.”;

(b) after Annexure-I, the following new annexure shall be inserted, namely:—
