NOTIFICATION

Subject: SUPPORT FOR EXPORT OF SUGAR

The ECC on 24-12-2014 has approved export of 0.65 M/tons of sugar to be exported by 15-5-2015 with inland freight support of Rs.2/- per K.G. and export support of Rs.8/- per K.G. (total cash support of Rs. 10/- per K.G.), with a financial implication of Rs.6.5 billion to be borne by the Federal and respective Provincial Governments on 50:50 sharing basis.

2. As directed by the ECC, the following procedure has been developed to complete the expeditious export of sugar and payment of cash support:-

- i. A Special Account will be opened at State Bank of Pakistan with the title "Support for Sugar Export";
- ii. Government of Pakistan, through Ministry of Finance, will deposit Rs. 1.625 billion in the said account as first tranche to start the export of sugar;
- iii. The said account will be replenished as the scheme progresses;
- iv. SBP will pay 100% cash support to the exporters of sugar for the exports originating from the province which concurs with the ECC decision dated 24-12-2014, while the Federal Government will deduct the provincial share of the respective province at source on the close of each month on actual basis. In the absence of such concurrence, SBP will make 50% payment of cash support to the exporters as Federal Government share;
- v. SBP will develop due procedure for the authorized dealers (ADs) for expeditious release of support as soon as export receipts are realized;
- vi. Necessary details of exports comprising name of exporter, location of mill, quantities, destinations and value etc. will be maintained by SBP and provide the same to Ministry of Finance on monthly basis.
