
OFFICE MEMORANDUM

SUBJECT: **EXPORT OF AN ADDITIONAL QUANTITY (0.3MMT) OF UREA UP TO 31.10.2017**

The undersigned is directed to refer to the subject noted above and to state that in continuation of its earlier decision in Case. No. ECC-13/4/2017 dated 23rd January, 2017 allowing an export of 0.3 MMT of urea fertilizer up to 28.04.2017, the Economic Coordination Committee (ECC) of the Cabinet in Case No. ECC-49/13/2017, dated 16th May, 2017 has further decided as under:

- i. Allowed increase in quantity of urea for export from 0.3 MMT to 0.6 MMT.
 - ii. Extended deadline for the export of urea from 28th April, 2017 to 31st October, 2017.
 - iii. Other terms and conditions imposed by the ECC under Case No. ECC-13/4/2017, dated 23rd January, 2017 for the export of urea will remain the same.
2. Copy of both the decisions of the ECC of the Cabinet in Cases Nos. ECC-49/13/2017, dated 16th May, 2017 and ECC-13/4/2017, dated 23rd January, 2017 are enclosed.
3. It is requested that actions to implement the decision of the ECC of the Cabinet may kindly be initiated forthwith under intimation to the Ministry of Commerce. In addition, State Bank of Pakistan (SBP) may also arrange via its website full disclosure of the record of quota allocation.
