The Competent Authority is pleased to notify the decision of the Economic Coordination Committee of the Cabinet ECC of the Cabinet Case No. EEC-138/24/2016 dated 13th December, 2016 regarding "Rebate on export of surplus wheat and wheat products".

ECC of the Cabinet considered the Summary, dated 9th December, 2016 submitted by the Ministry of National Food Security and Research titled "Rebate on export of surplus wheat and wheat products)" and approved the proposals contained in Para-3 of the Summary subject to the condition that the export process should be completed by 31st December, 2016, and the process of paperwork for getting export rebate should be completed by 28th February, 2017. The para-3 of the Summary is reproduced as below:

"The production for the wheat crop 2015-16 was achieved at 25.45 million tons. The public sector procured 5.802 million tons and with addition of leftover stock of 4.117 million tons, a quantity of 8.139 million tons wheat stocks are available in the country. In view of the situation where more than 3 million tons exportable surplus wheat is available, the Ministry of National Food Security and Research supports the proposal of Government of Punjab to allow export of the equal quantity of Suji, Maida and wheat flour Fine (Aata)/ equivalent to the wheat issued. Meaning thereby that one Kg of Suji, Maida and wheat flour Fine (Aata) will be exported against one Kg of wheat issued so there will be no extra claim of rebate. The export should be allowed till 31st December, 2016 and export process to be completed till 28th February, 2017".

2. The terms and conditions will remain same as was allowed by the ECC of the Cabinet in its meeting held on 26th July, 2016 in case No. ECC-93/15/2016 dated 26th July, 2016.()

The Competent authority is pleased to notify the decision of the Economic Coordination Committee (ECC) of the Cabinet in case No. ECC-93/15/2016 dated 26th July, 2016 as per details given below:

The ECC of the Cabinet considered the Summary dated 22nd July, 2016 submitted by the Ministry of National Food Security and Research titled "Rebate on Export of Surplus Wheat/Wheat Flour (Atta)" and approved the proposal of additional rehate of US\$ 30/- per ton on export of wheat and wheat flour (Atta), to be shared @ 50:50 by the federal and provincial governments (Punjab and Sindh) [mentioned in Para-7 (a) of the Summary].

2. The ECC of the Cabinet also approved the following:

This rebate would be over and above the rebate already approved by ECC @ US \$ 55/- per ton for Punjab and US\$ 45/- per ton for Sindh respectively. In addition to this rebate, as in past, additional rebate of US\$ 35/- and 45/- per ton would be provided by the Government of Punjab and Sindh respectively. This addition will enhance the total rebate to US\$ 120/- per ton. The quantity allowed to be exported is proposed to be 6.00,000 tons and 3,00,000 tons for Punjab and Sindh respectively. The export shall be allowed till 30th November, 2016 and export process to be completed till 31st January, 2017.

- 3. The following procedure would be adopted to implement the above Decision.
- a. The Provincial Governments and Wheat Exporters will sign an agreement for export of wheat.
- b. Exporters will submit a Letter of Credit (LC) for 45 days plus bank guarantee equivalent to amount of subsidy (in PKR). The Bank guarantee will be automatically released on validation of export documents by the Provincial Governments.

The ECC of the Cabinet considered the Summary dated 11th January, 2016 submitted by the Ministry of National Food Security and Research regarding "Extension in Export of Wheat" and took the following decisions:

- Allowed export of 400,000 tons of wheat & wheat flour (Atta) by the (a)Government of Punjab and 200,000 tons by the Government of Sindh at a support / rebate of US \$ 55 and US \$ 45 per ton, respectively with effect from 13 January, 2016 till 15 March, 2016.
- As previous approval of the ECC of the Cabinet for the export of (b) wheat and Wheat flour (Atta) by the Punjab and Sindh Provinces was upto 30th September, 2015, therefore, export of Wheat and Wheat flour (Atta) made during the period from 1st October, 2015 to 12th January, 2016 shall not be entitled for any cash support/rebate.
