Suggestions for Promoting Exports of Software

As you are aware that the State Bank of Pakistan (SBP) regulates movement of foreign exchange to and from Pakistan under the powers conferred on it by the Foreign Exchange Regulation Act, 1947.

- 2. In this regard, instructions related to Export of Software are contained in Para 12, Chapter 12 of F.E. Manual-2017. The instructions, interalia, provide guidelines for registration of exporters with the concerned Area Office of the Foreign Exchange Operations Department, SBP-Banking Services Corporation and realization & retention of the proceeds of such exports in foreign currency accounts.
- 3. SBP is considering reviewing the instructions relating to export of software so as to facilitate exporters by removing hurdles/impediments, if any, to enable them to enhance their exports.
- 4. We would highly appreciate valuable suggestions/proposals in the above context within a fortnight.
- 5. On receipt of proposals a meeting would be called at SBP to finalize the arrangements agreed to.
