Formulation of Scheme for LTF-EOP

The State Bank of Pakistan has formulated a scheme for Long Term Financing for the Export Oriented Projects (LTF-EOP). The scheme envisages provision of long term financing for the establishment of the export oriented projects and / or for the import of new machinery.
