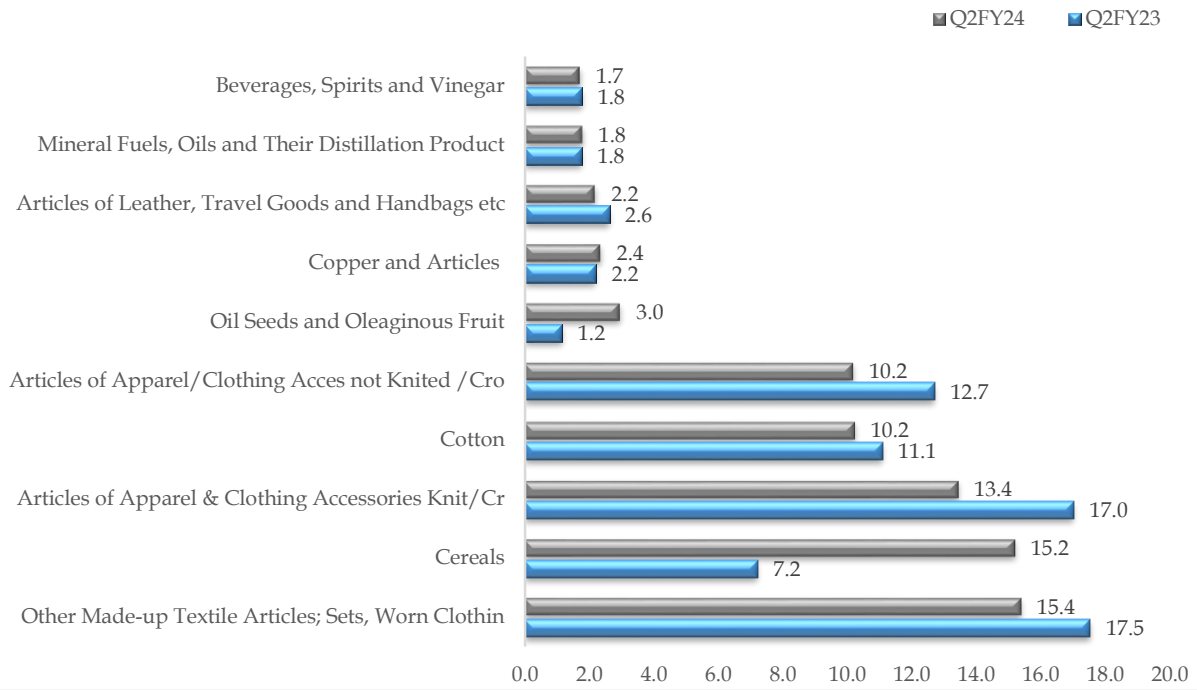

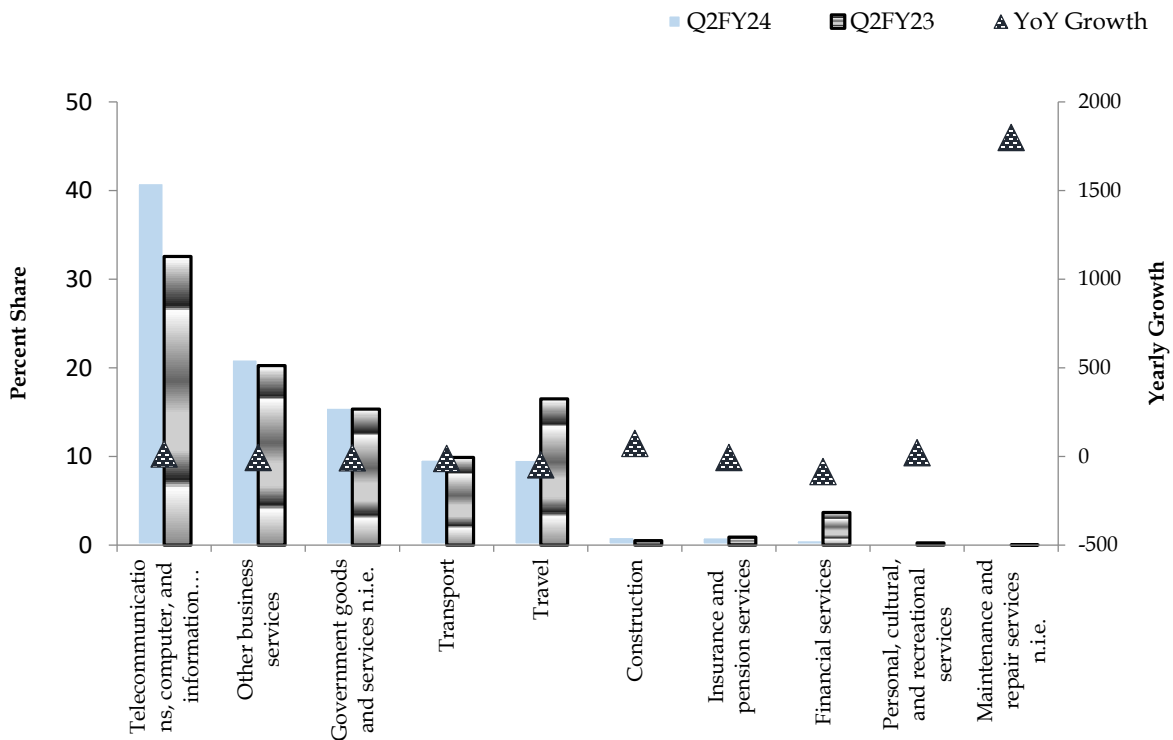
Percent Share of Major Commodities in Export Receipts of Goods (Scheduled banks)

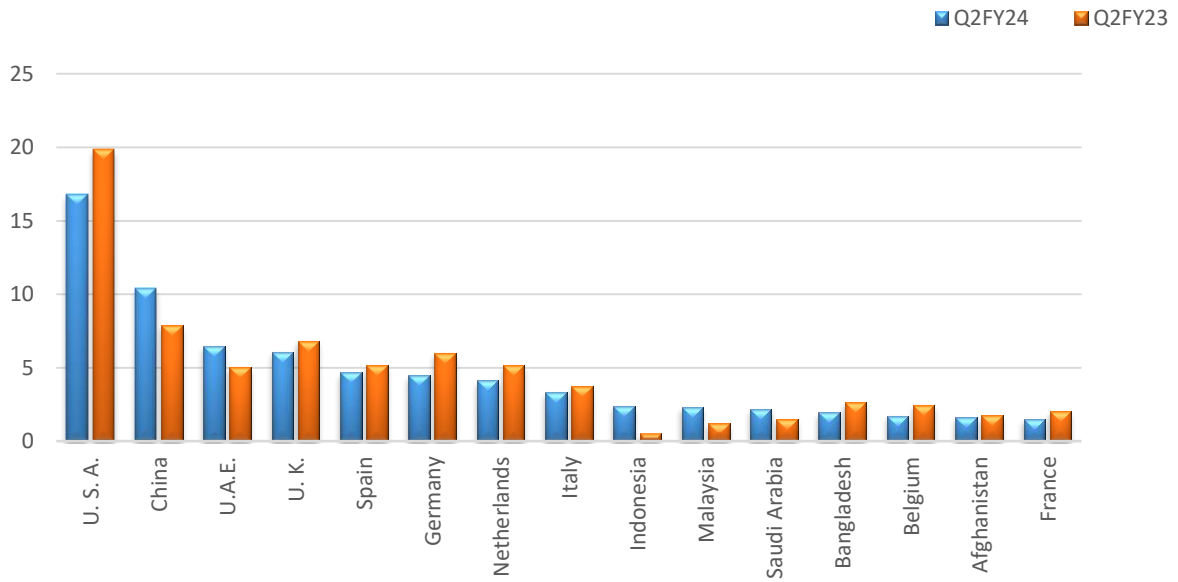

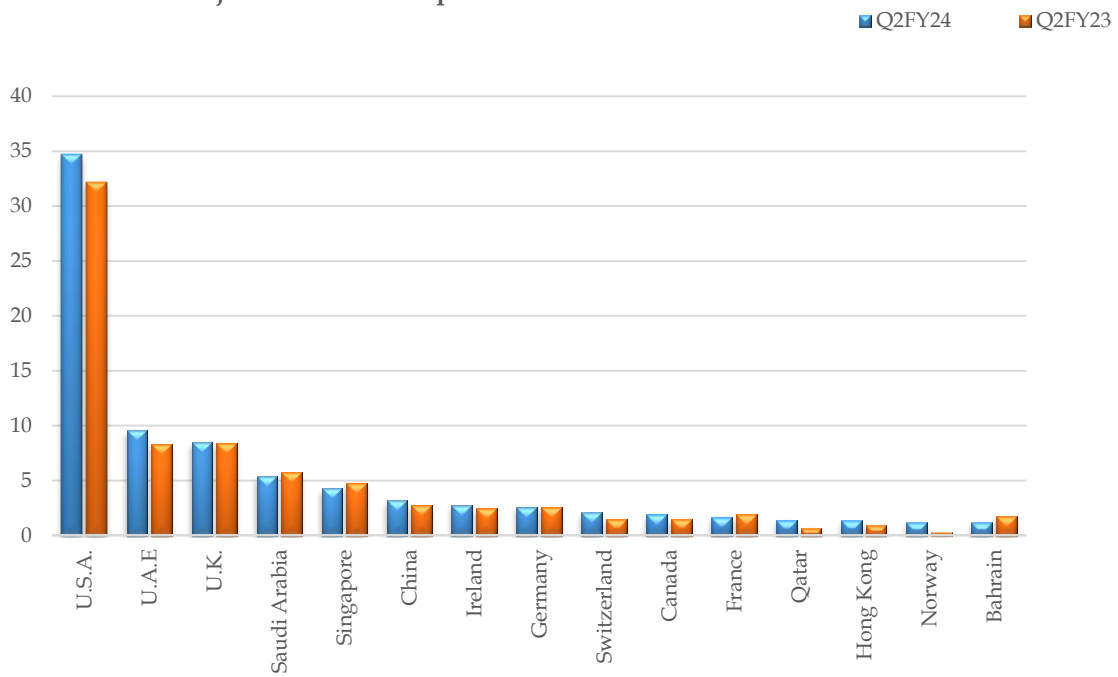
Percent Share of Major Countries in Export Receipts of Goods (Scheduled Banks)

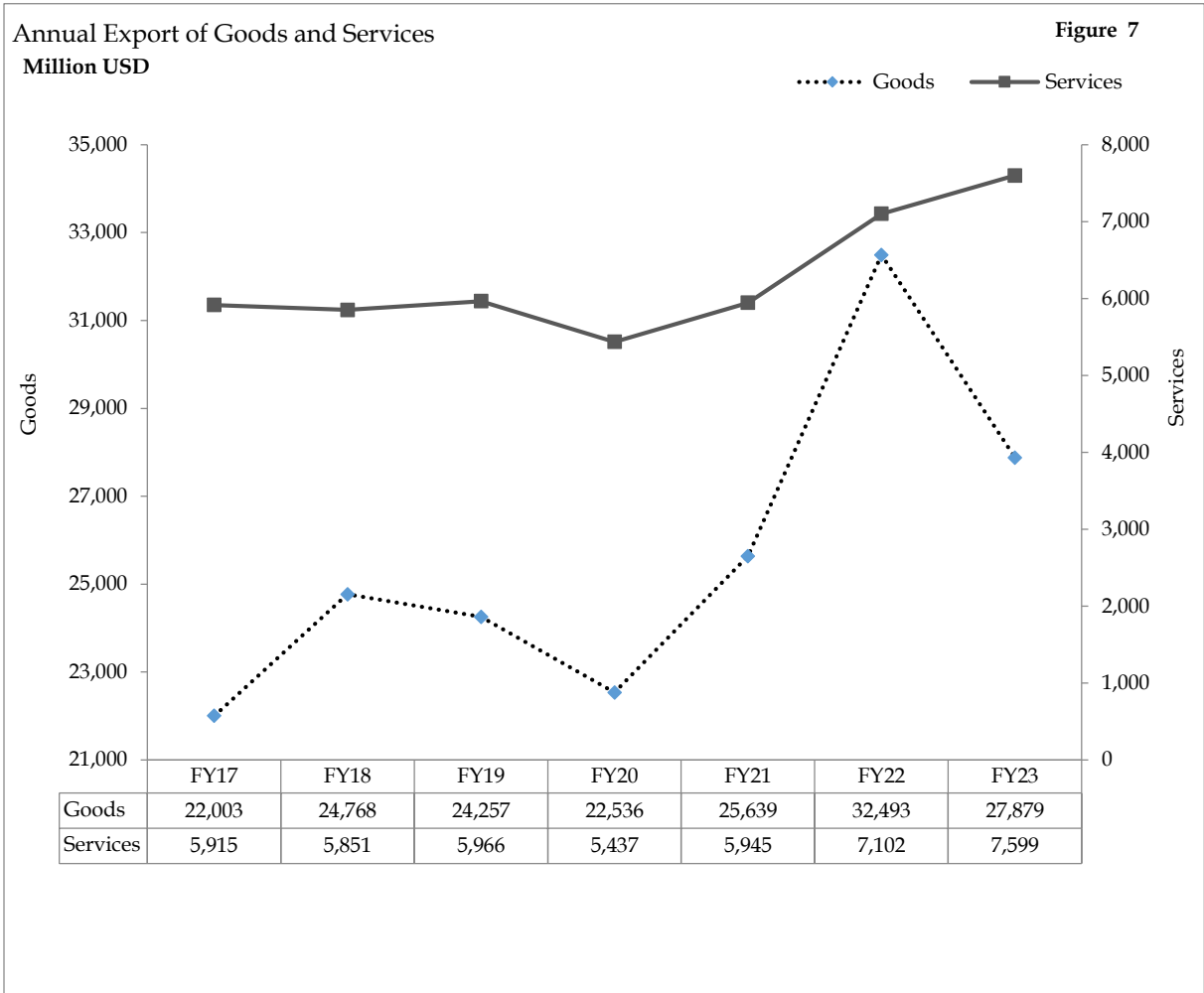
