Terms & Conditions

1. Bidders may submit quotations for one or more COMPLETE CONTRACT PACKAGE, evaluation of quotation and contract award will be package wise
2. The Bidders are required to attach the relevant brochures explicitly mentioning in their Quotation: Make/ model, Brand, Country of Origin/ Manufacturing country, etc. For equivalent products Bidder should clearly highlight the functional equivalence of the offered product.
3. Quotations shall be in accordance with the specification.
4. Price quoted shall be inclusive of all applicable taxes and duties and cover installation at various locations as indicated or as advised otherwise.
5. A weight age of 60% would be given on conformity with specifications and 40% on quoted price
6. Firms submitting the quotations shall meet the following criteria:
The Vendor must have at least five years of experience in service providing similar to these mentioned above. Documentary evidence, interalia, Authorized Dealership Certificate, must be provided with the quotation.
7. Proof of registration with the Income Tax Department and Sales Tax Department should be enclosed with the quotation.
8. Quotations shall be valid for a period of 60 days after opening.
9. The supplier will deliver the items within six weeks after issuance of Purchase Order. However the vendor is required to deliver the ordered equipment as soon as possible within minimum allowable time.
10. All Government taxes shall be deducted as per law.
11. Bidders are requested to give their best and final prices as no negotiations are expected.
12. Bidders engaged in corrupt or fraudulent practices (including collusion / pooling) will be declared ineligible, either indefinitely or for a stated period of time.
13. Results of bid award would be made known in a reasonable time, Bidders are instructed not to approach the Bank Authorities after opening of bids until the finalization of award.
