All the firms / contractors dealing in above works and providing services to organizations of good repute are invited to submit their rates on Bank's contract form for fumigation, rats & rodent control and termite proofing at the entire office premises as detailed hereunder:-

- 1. The quotations in sealed covers addressed to the Chief Manager should reach this office on or before 20th October, 2008 at 11:00 AM.
- 2. The quotations will be opened at 11:30 AM on the same day in presence of the bidders who may like to be present.
- 3. Earnest money @ 2% of the quoted amount should be submitted in cash or in the shape of Pay Order, Bank Draft in favor of the Chief Manager.
- 4. Conditional, incomplete and the quotations without earnest money shall not be accepted.
- 5. The rates should be inclusive of all Govt. Taxes.
- 6. The bidders should furnish documents testifying their previous experience in the field.
- 7. The contact form can be obtained from the office of the undersigned (Engineering Unit SBP BSC (Bank), Peshawar) on any working day but not later than 18th October, 2008.
- 8. The successful bidder will be required to deposit Rs.25,000/- as security and will execute an agreement with the Bank on its standard format before issue of work order.

TERMS / CONDITIONS FOR FUMIGATION, RATS & RODENT AND TERMITE CONTROL AT STATE BANK OF PAKISTAN SBP BSC (BANK), OFFICE PREMISES PESHAWAR.

- 1. Entire Office premises comprising Tower Block Building, Banking Hall, Vaults Area, Connecting Bay, Annexe Building, Service Block, Security Rooms, Sentry Posts and Mosque etc. shall be treated for the above works to the utmost satisfaction of the Bank.
- 2. The treatments including fumigation, surface spray, provision of rat killer medicines, termite proofing etc. shall be carried out on quarterly basis and the contractor shall ensure complete elimination of flying and crawling insects & rats etc. during the period where after next phase of fumigation treatment gets due.
- 3. The pesticides used in the treatment should not be harmful for human life in all regards.
- 4. Bill against fumigation treatment shall get due for submission after one week time from the date of treatment completed. During the period efficacy of the fumigation shall be observed.
- 5. Any complaints regarding emergence of flying and crawling insects during the period between two consecutive phases of fumigation treatment shall be attended to by the firm / organization by repeating any / all the treatments (Rates & Rodent Control, Fumigation, Spray etc. whichever applicable) free of cost, till the effective eradication of the problem.
- 6. The firm / organization shall furnish a certificate after the treatment that the office premises is quite safe against all infestations / termite, flying and crawling insects, rats and rodents etc.
- 7. All the Govt. Taxes shall be applicable on the amount of bill submitted as levied by the Bank, at the time of submission of bill.
- 8. Earnest money @ 2% shall be deposited by the parties interested in carrying out the job.
- 9. A sum of Rs.25,000/- shall have to be deposited by the successful bidder as security deposit lying with the Bank till 90 days after expiry of the contract agreement.
- 10. The security deposit may be forfeited by the Bank to make good any losses due to inefficacy of the cited treatments, within the contract period.
- 11. The agreement may continue for further period with the consent of both Parties until and unless declared in writing.
- 12. The party quoting the rates should inspect the entire office premises before quoting its rates, so as to form a practical view of the work.
