It is mentioned that 200 KVA Cummins Diesel Generator installed at North Nazimabad Office, Karachi has been operating/maintaining by M/s. S.A.S. Corporation, Karachi since long. Last year contract agreement for the above job was executed with them for a period of one year i.e. up to 31-10-2008 at a cost of Rs.22,000/-.per month However, as per PPRA Rules-2004 tenders for the captioned work were invited through PPRA & Bank's Websites on September, 11 2008 and opened on October 14,2008 in presence of representatives of bidders and concerned officials of this Department. Only two bidders participated in the bid. Details of the bids are as under: -

Rs.42,000/-

It is obvious from the above that the rates of Rs.38,000/- per month quoted by M/s. S.A.S. Corporation, Karachi are the lowest, reasonable & workable for round the clock operation and maintenance including Sundays/Holidays of 200 KVA Diesel Generators. The contractor will provide one operator to be present round the clock.

As per answer to question in Rule-21 of PPRA's rules single bid is also entertained for awarding the work. Beside M/s S.A.S Corporation, Karachi is well-reputed firm and services hired earlier by the Bank were satisfactory. Further they were advised to continue their services uptil finalization of a new contract. The contractor is responsible for operation of the Generator for round the clock.
