- 4. The bidders are requested to give their best and final prices as no negotiations are expected. The rates quoted must remain valid for a period of ninety (90) days after opening of bids.
- 5. Technical brochure containing detailed specifications must be provided with the bid. The bidder must mention brand name, model and brand country of the offered product to be supported by documentary evidence.
- 6. All bids must accompany a bid security in the form of Pay order/Bank draft/Cheque of 2% of the bid price.
- 7. Interested eligible bidders may obtain further information and can purchase the bidding documents on submission of a written application upon payment of a nonrefundable fee of Pak Rs 500/- only through bank draft/pay order in the favor of State Bank of Pakistan, Karachi from the address given below or any field office of SBP throughout Pakistan during office hours after publication of IFB till closing thereof.
