

## **Invitation for Bids (IFB)**

1. State Bank of Pakistan, Banking Services Corporation invites sealed bids from tax registered eligible Bidders for supply, installation and warranty maintenance of following office equipment:

Description	Quantity
Floor Mounted Type 4 tons Air Conditioner	1
Split Air Conditioner 2 Ton	2

2. Bidding will be conducted using the National Competitive Bidding procedures specified in the Public Procurement Rules 2004 (PPR 2004); as adopted by State Bank of Pakistan, and is open to all eligible Bidders as defined in the PPR-2004 that meet the following minimum qualification criteria:

Bidders must be a manufacturer or a direct authorized agent of the manufacturer of required equipment in Pakistan with a minimum of five (5) years of experience in manufacturing **or** supplies and services; as applicable. Agent should be in possession of a currently valid Authorization Certificate Manufacturer/Supplier should have a documented track of completing at least five (5) similar assignments, during last 5 (five) years, involving the supply, installation, and provision of technical support for procurement of a comparable scale. Delivery and installation within ONE week of issuance of Purchase Order will be required.

- 3. The Bidders are requested to give their best and final prices as no negotiations are expected. The rates quoted must remain valid for a period of **ninety days** after opening of bids.
- 4. All bids must be accompanied by a bid security of not less than 3% of the bid price. If items specified in technical specifications are quoted as options, the cost of same would be summed together to calculate the quoted price and bids would be rejected if the bid security does not cover the adjusted quoted rates. Late bids will be rejected. Bids submitted without unsigned bid forms will be rejected.
- 5. Interested eligible Bidders may purchase the bidding documents on the submission of a written application to the address below and upon payment of a nonrefundable fee of Pak Rs 500 only through bank draft/call deposit in favor of SBP BSC, from the address given below from 09:00 am to 05:00 pm after publication of IFB till closing thereof. If post courier requests the bidding documents then non-refundable fee of Pak Rs. 700 will be charged. - 6. Bank's rights for rejection of all bids will be exercised as stipulated in PPR-2004
- 7. Bids must be delivered to the address below on or before **December 19, 2012** at 10:30 hours. Bids will be opened in the presence of bidders' representatives who choose to attend at 11:00 hours same day at the Meeting Room of General Services Department at 4<sup>th</sup> floor, State Bank of Pakistan, Banking Services Corporation, Karachi.
