**Quotations for Disposal of Un-Serviceable Miscellaneous Items Lying at State Bank of Pakistan Premises, I.I. Chundrigarh Road, Karachi**

Sealed Quotations/ Tenders are invited from the interested parties for the disposal of different scrap/ un-serviceable items/ equipments on “As is, Where is” basis. The materials include various electrical/ mechanical/ civil items like fans, lights, used mobil oil, Ac compressors, batteries, DBs, Plastic Cans, water coolers, door closers, computer tables, MS/ GI items etc.

1. Tender Documents can be obtained from the office of the undersigned at SBP BSC (Bank), 1<sup>st</sup> Floor, Bolton Market Building M.A Jinnah Road Karachi during office hours on working days not later than **21.01.2013** on payment of specified tender fee (non-refundable) of **PKR 300/-** with written request/application on company letter head.
2. The Bidders are required to quote for all the items mentioned in the lists given in the Tender Documents.
3. The amount of Earnest Money/ Bid Security for the above tender is 5% of the total quoted amount payable in the form as specified in the Bidding Documents in favour of the State Bank of Pakistan.
4. Bidding will be conducted under National Competitive Bidding Procedure as per the provisions of Public Procurement Rules-36(a) single stage, single envelope procedure- (PPRA-2004-2010).
5. Bids should be dropped in the Tenders Drop Box kept in the office of the PA to Head Engineering, 1<sup>st</sup> Floor, SBP BSC Bolton Market Building, M.A Jinnah Road Karachi, by or before the **22.01.2013** till **03:00PM**. The Bids shall be opened on the same day at **13:30PM** in the presence of the Bidders or their authorized representatives who may like to be present during the session.
6. Bid of any bidder shall be cancelled if the bidder is found blacklisted by any organization at any stage during tendering process or execution of the Contract.

7. The bid of any bidder shall be declared non-responsive if he is found involved in litigation with any government or semi-government department.
8. If any clarification is required, the query may be sent to the undersigned through registered courier, e-mail or fax, at least **07** days prior to the date fixed for submission of bids. All replies to the queries or addendum etc. shall be considered part of the bidding documents and should be signed and submitted along with the Bid.
9. In case of any unforeseen reasons, unrest or force majeure on the bid submission/opening date, the tender shall be opened on the next working day at the same place and time.
10. The Bids shall remain valid for a minimum period of **25** days from the date fixed for submission of the Bids.
11. No Bidding Documents shall be sold on the date fixed for opening of the Bids.
12. Incomplete, conditional and Bids without appropriate earnest money shall not be considered.
13. These tenders are only invitation to offer and Bank does not bind itself to accept the any Bid as per PPRA rules.
14. Further, personal convincing, recommendation or unauthorized practices for getting the Contract, will also disqualify the bidders.
