- Tender shall be submitted in accordance with the Schedule of Prices, Specifications and other provisions of the tender documents provided to the intended bidders. Bids shall be evaluated on the basis of **evaluation criteria** given in the tender documents.
- Contractors/contracting firms or companies are required to have minimum **EIGHT (08)** years experience in Operation and Maintenance of Absorption and Air Cooled Screw type Chillers of at least **500 TR capacity** of reputed/multinational organizations and have their own workshop & store for related spare parts of Cooling Towers, Pumps, Air Handling Units, Fan Coil Units and Allied Equipment to keep the above plant operational.
- Bidding shall be conducted using the National Competitive Bidding Procedure specified in the PPRA Rules 2004 and is opened to all eligible bidders that meet the minimum qualification criteria mentioned in the tender documents.
- Technical & Financial Bids shall be valid for a minimum of **120 days** from date of submission of Bid.

- No Tender Documents shall be sold on the date fixed for opening of the Tender.
- The Earnest Money **should not less than 2% of the total One Year Operation and Maintenance quoted price** in shape of pay order as also mentioned in the tender documents should be submitted with the tender. (Cash will not be acceptable)
- Incomplete, conditional and tenders without required amount of earnest money in the specified form/format shall be rejected.
- The technical and financial proposals should be sealed separately and be placed in 3<sup>rd</sup> envelope.  
The name of the bidder and tender description (Name and technical or financial bid) shall be clearly marked on all envelopes. Tender should be dropped in tender box kept in the office of the PA to Director Engineering at 1<sup>st</sup> floor SBP Bolton Market Building, M.A. Jinnah Road, Karachi as per the detail mentioned in the above table.

- In case of any query the department may contacted not before five working days of tender opening through correspondence.
