Sealed tenders are invited for the above job from the civil contractors / contracting firms registered with Pakistan Engineering Council at least in Category C-6 with specialization CE-10.

The contractor's / contracting firms are also required to furnish along with their application for issuance of Bidding Documents, the following / information / documentary evidence:

- i. Copy of valid registration certificate with Pakistan Engineering Council.
- ii. Copy of Income Tax Registration Certificate.
- iii. Copies of work orders for at least two similar completed jobs of Water Proofing Treatment with fiber glass sheet during last three years.

Bidding will be conducted under National Competitive Bidding Procedure specified in the Public Procurement Rules 2004 (PPRA-2004) as per Rule -36 (b), under Single Stage and Two Envelopes procedure. Technical and Financial proposals should be submitted in two separate sealed envelopes and be placed in outer envelope. The name of the bidder and tender description (Name and technical or financial proposal) shall be clearly marked on all envelope).

The amount of earnest money for the job is 2% of the quoted amount payable in the form as specified in the bidding documents, in favor of NIBAF, Islamabad. Tenders along with requisite Earnest Money should reach the office of the Joint Director (Administration) National Institute of Banking & Finance, State Bank of Pakistan Sector H-8/1 Pitras Bukhari Road Sector H-8/1 Islamabad on or before September 04, 2014 till 03:00 P.M. Technical Proposals shall be opened in Board Room of NIBAF, Pitras Bukhari Road Sector H-8/1 Islamabad on same date at 03:30 PM in the presence of bidders or their representatives who may like to attend the session. The Financial Proposal of Technically qualified bidders will be opened on date, time and venue communicated to qualified bidders. No tender documents shall be sold on the date fixed for opening of tenders. In case of any unforeseen reasons, public holiday, unrest or force majeure on the bid submission / opening date, the tender shall be opened on the next working day at the same place and time.

Incomplete, conditional and bids without 2% of bid amount as earnest money shall not be considered responsive. These tenders are only invitation to offer and bank does not bind itself to accept the lowest or any tender as per PPRA rules.
