## **TENDER NOTICE**

## Procurement of Canteen Contractor at State Bank of Pakistan SBP BSC (Bank), Lahore.

State Bank of Pakistan, SBP Banking Services Corporation (Bank) Lahore invites sealed bids from the reputable Caterers to provide hygienic and quality foods at the Bank's Canteen for the employees of the Bank for a period of two years, extendable for further one year subject to satisfactory performance and with mutual consent.

The bidder will be selected through single stage-one envelope procedure as prescribed under Rule 36 (a) of Public Procurement Rules (PPR 2004) and conforming to the procedure described in the bidding documents.

Eligible bidders should meet the following minimum qualification criteria:

- a. Bidder must be registered with Taxation Authorities.
- b. Bidder should have experience of providing canteen services (in hand) and executed during last five years.
- c. Bidder shall submit reference letters of satisfactory canteen services from existing and previous clients to endorse the criteria at sub para (b) above.
- d. Bidder shall provide a list and profile stating CNIC No. of well trained team of cooks having min. three (03) years experience & other support staff having experience in preparing quality, healthy & hygienic food.
- e. Bidder should not be in litigation with/ blacklisted by any client. An affidavit in this regard must be provided.
- f. Bidder should not have history of any terminations on account of service related issues. An affidavit in this regard must be provided.

The bidders who do not meet any of the above conditions will be primarily disqualified from the bidding process.

The rates must be quoted as per format given in IFB and shall remain valid for a period of ninety (90) days from opening date of bids.

All bids must be accompanied with refundable earnest money of Rs.5,000/- (Rupees five thousand only) Through Bank Draft / payment order / CDR in favour of State Bank of Pakistan, SBP BSC (Bank), Lahore. Late bids, incomplete bids, bids without bid/earnest money and conditional bids will be rejected.

Eligible bidders may purchase bidding documents on submission of a written application on the Firm's letter head to the below mentioned address and upon payment of a non-refundable fee of Rs. 500/- (Rupees five hundred only.) after publication of IFB till one day before closing thereof.
