**TENDER NOTICE**

**Up-Gradaation and Improvement of Physical Environment of Main Building Phase-I**

**(Improvement/Up-gradation of Toilet Blocks, Replacement of Carpet Flooring with Tiles & Replacement of False ceiling at two floors of Main Building, Replacement of MS Glazed Windows with uPVC Windows)**

Sealed Tenders are invited for the above job from the civil contractors / contracting firms registered with Pakistan Engineering Council at least in Category C-5 with specialization category CE-10.

Complete set of Tender Documents, Specifications and Drawings can be obtained from the office of Engr. Imran Aslam, Executive Engineer, **1<sup>st</sup> Floor, SBP Bolton Market Office Building, M.A Jinnah Road, Karachi**, against payment of **Rs. 2,000/- (Rupees Two Thousand only)** in form of Pay Order (Non-Refundable) as Tender Fee. The contractors/ contracting firms are also required to furnish along with their application for issuance of Bidding Documents, the following information/ documentary evidence;

- i. Copy of valid registration certificate with Pakistan Engineering Council.
- ii. Copy of Income Tax Registration Certificate.
- iii. Copies of work orders or completion certificates for two completed similar jobs costing at least Rs. 15.0 Millions during last three years.

Bidding will be conducted under National Competitive Bidding Procedure specified in the Public Procurement Rules 2004 (PPRA-2004) as per **Rule-36(b), under Single Stage, and Two Envelopes** procedure. Technical and financial proposals should be sealed in two separate envelopes and be placed in 3rd sealed envelope. The name of the bidder and tender description (Name and technical or financial proposal) shall be clearly marked on all envelopes.

The amount of Earnest Money for the job is **2%** of the quoted amount payable in the form as specified in the bidding documents, in favour of State Bank of Pakistan. Tenders along with requisite Earnest Money should be dropped in tender box kept in the office of the PA to Director Engineering at 1st floor SBP Bolton Market Office Building, M.A. Jinnah Road, Karachi on or before November **28, 2014 till 03:00PM**. Technical Proposals shall be opened at office of the Engineering Department, 1st floor SBP Bolton Market Office Building, M.A. Jinnah Road, Karachi on same date at **03:30PM** in the presence of bidders or their representatives who may like to attend the session. No tender documents shall be sold on the date fixed for opening of the tenders. In case of any unforeseen reasons, public holiday, unrest or force majeure on the bid submission/opening date, the tender shall be opened on the next working day at the same place and time.

Incomplete, conditional and bids without 2% of bid amount as earnest money shall not be considered responsive. These tenders are only invitation to offer and Bank does not bind itself to accept these tenders as per PPRA rules. Further, personal canvassing, recommendation or unauthorized practices for getting the Contract, will also disqualify the bidders. Further details are provided in the Bidding Documents.
