

Invitation for Bids (IFB)

Procurement Division, General Services Department (SBP BSC) on behalf of State Bank of Pakistan invites sealed bids from eligible bidders for “*Procurement of Services of Canteen Contractor*”.

Bidding will be conducted under National Competitive Bidding pursuant to Rule 36(b) “Single stage two envelope procedure” as per Public Procurement Rules-2004 and is open to all eligible Bidders as defined in PPR-2004 that meet the following minimum eligibility/qualification criteria.

- a. The bidders must be registered with tax authorities.
- b. The bidders must have at least 5 (five) years experience of providing Canteen services
- c. The bidders must have proven record of providing canteen services for minimum 300 persons daily to at least three (3) comparable organizations during the last five (05) years.
- d. The bidders should not be in litigation with and or blacklisted by any client.
- e. The bidder should not have history of any terminations on account of service related issues.

The rates quoted must remain valid for a period of **120** days after opening of the bids. Bid security of Rs. 100,000/- (Rupees one hundred thousand only) must be accompanied by **Financial Proposal** in sealed envelope. Late bids will be rejected. Bids submitted without signed **Bid Form** by authorized nominee of the bidder will be rejected. Bid with material deviation, exception, objection, conditionality or reservation shall be rejected. Bid found with insufficient /without earnest money will also be rejected instantly at the time of opening of financial proposals. Bidders will submit bids for COMPLETE REQUIREMENTS.

Interested eligible Bidders may obtain further information if required and purchase the bidding documents on submission of a written application, upon payment of nonrefundable fee of **Rs.500/-** only through Bank Draft/Pay Order drawn in favor of SBP BSC, HOK from the address given below from **8:00 am to 2:00 pm** after the publication of IFB till closing thereof. If the bidding documents are requested by post, a non-refundable fee of **Rs.700/-** will be charged. IFB is also uploaded for display on the websites <http://www.ppra.org.pk> and <http://www.sbp.org.pk>.

Bids must be delivered to the address below on or before **August 12, 2014 at 03:00 pm**. Bids will be opened in presence of the bidders’ representatives who choose to attend at **03:30 pm** same day at Learning Resource Centre, State Bank of Pakistan, I.I. Chundrigar Road, Karachi.
