3. The rates quoted should be valid for a minimum period of **120 days** from the date of submission of Bid.

Prescribed tender documents can be obtained from the Office of the under signed at 1st floor SBP Sub- Office Building opposite Boulton Market, Karachi on payment as mentioned in the above schedule against Cash / Pay Order / Demand Draft (non-refundable) in favor of State Bank of Pakistan & on production of Request Letter on Company's Letter Head and copy of Sales Tax Certificate, Income Tax Certificate and Company's Profile on any working day.
5. No Tender Documents shall be sold on the date fixed for opening of the Tender.
6. The earnest money should not be less than **2%** of the total quoted amount in the shape of pay order/ demand draft in favor of State Bank of Pakistan should be submitted with the tender whereas **cash will not be allowed**.
7. Tenders without earnest money in the specified form, incomplete or conditional tenders shall be rejected.
8. Tender should be dropped in tender box kept in the office of the PA to Director Engineering at 1st floor SBP Bolton Market Building, M.A. Jinnah Road, Karachi as per the detail mentioned in the above table.
