Bids shall be evaluated on the basis of evaluation criteria given in the Tender Documents. In case of non-compliance of Bid Evaluation Criteria, bid will be considered as non-responsive.
- 3. The rates quoted should be valid for a minimum period of <u>120 days</u> from the date of submission of Bid.
