- 1. Tender shall be submitted in accordance with the Schedule of Prices, Specifications and other provisions of the tender documents provided to the intended bidders. Bids shall be evaluated on the basis of **Bid Evaluation Criteria** given in the tender documents.
- 2. Bidding will be conducted under National Competitive Bidding pursuant to 'Single stage two envelopes procedure' as per **Rule 36(b)** of Public Procurement Rules 2004 (PPR 2004) and is open to all eligible Bidders as defined in the PPR 2004 that meet the following minimum eligibility/qualification criteria:
 - a. Registered with Income Tax Department (Valid NTN Certificate).
 - b. Registered with Sales Tax Department (Valid GST Certificate).
 - c. Registered with Pakistan Engineering Council (PEC) (Valid Registration Certificate)
 - d. Bidders must be OEM(s) or OEM Authorized Agent or firms in a Joint Venture or Consortium (Authorized by their respective OEMs).
 - e. Bidders must be authorized by their OEM(s) specifically for this procurement.
- 3. Technical & Financial Bids shall be valid for a minimum of 120 days from date of submission of Bid.
- 5. Prescribed tender documents along with copy of terms and conditions can be obtained from the Office of Mr. Qazi Ahmed Arif, Executive Engineer (E/M) Engineering Department (Phone:021-32454144) SBP Boulton Market Building, Karachi on payment as mentioned in the above schedule against Pay Order/Demand Draft (non-refundable) in favor of State Bank of Pakistan & on production of Request Letter on Company's Letter Head along with Company's Profile and valid Certificate of registration with Pakistan Engineering Council (PEC) as mentioned above copy of Income Tax Registration certificate and copy of work order etc.
- 6. No Tender Documents shall be sold on the date fixed for opening of the Tender.
- 7. The Earnest Money **should not less than 2% of the total quoted price** in shape of pay order as also mentioned in the tender documents should be submitted with the tender (cash will not be accepted).
- 8. Incomplete, conditional and tenders without required amount of earnest money in the specified form/format shall be rejected.
- 9. The technical and financial proposals should be sealed separately and be placed in 3rd envelope.
 - The name of the bidder and tender description (Name and technical or financial bid) shall be clearly marked on all envelopes. Tender should be dropped in tender box kept in the office of the PA to Director Engineering at 1st floor SBP Bolton Market Building, M.A. Jinnah Road, Karachi as per the detail mentioned in the above table.
- 10. This tender is only an invitation to offer and the Bank does not bind itself to accept any tender and reserves the right to reject any / all tenders as per PPRA Rules.
- 12. In case the tender is not opened on the scheduled date due to any force de majeure then the same shall be opened on the next working day at the same time and place. Further details are provided in the tender documents.
- 13. Personal canvassing or recommendation or unauthorized practices for getting the contract will also disqualify the bidders.
