- Tender shall be submitted in accordance with the Schedule of Prices, Specifications and other provisions of the tender documents provided to the intended bidders. Bids shall be evaluated on the basis of evaluation criteria given in the tender documents.
- Bidding of the LOT-I will be conducted under National Competitive Bidding pursuant to 'Single stage two envelopes
 procedure' as per Rule 36(b) of PPR 2004 and is open to all eligible Bidders as defined in the PPR 2004 that meet the
 following minimum eligibility/qualification criteria:
 - a. Registered with Income Tax, Sales tax Department and Pakistan Engineering Council.
 - c. Bidders must be OEM(s) or OEM Authorized Agent.
 - d. Bidders should have completed minimum five similar natures of the work(s) of the same or above capacity.
- 3. Bidding of the LOT-II will be conducted under National Competitive Bidding pursuant to 'Single stage-one envelope procedure' as per **Rule 36** (a) PPR 2004 and is open to all eligible Bidders as defined in the PPR 2004 that meet the following minimum eligibility/qualification criteria:
 - a. Registered with Income Tax Department.
 - c. Completion certificates with contact details for two completed similar jobs costing at least Rs. 1.00 Millions during last three years.
 - g. The firms/ Bidders/ Suppliers blacklisted by any Government/Semi-Government /any other organization and State Bank of Pakistan (SBP) shall not be eligible to bid affidavit to be provided.
- 4. Technical & Financial Bids shall be valid for a minimum of <u>120 days</u> from date of submission of Bid.

- 6. No Tender Documents shall be sold on the date fixed for opening of the Tender.
- 7. The Earnest Money should not less than 2% for each lot of the total quoted price in shape of pay order as also mentioned in the tender documents should be submitted with the tender (cash will not be accepted).
- 8. Incomplete, conditional and tenders without required amount of earnest money in the specified form/format shall be rejected.
- 9. The technical and financial proposals should be sealed separately and be placed in 3rd envelope.
