## State Bank of Pakistan (SBP BSC) Invitation for Bids (IFB)

- 1. State Bank of Pakistan Banking Services Corporation (SBP BSC) intends to procure High-end Banknote Processing and Authentication System (BPAS) for SBP BSC.
- 2. General Services Department, SBP BSC invites sealed bids (technical and financial proposals sealed in separate envelopes) from eligible bidders for "Supply, Installation, Integration, Testing, Commissioning, Handing Over, Maintenance & Support of High-end Banknote Processing & Authentication System (BPAS) with online Shredding, Packaging, Bundling and Shrink Wrap System along with conveyor system and briquetting solution for online/offline shreds & all ancillary equipment including HVAC System at State Bank of Pakistan, Banking Services Corporation (SBP BSC)" as per details mentioned in the "Technical Specification" in the Bidding Documents.
- 3. Bidding will be conducted under International Competitive Bidding and 'Single stage two envelope bidding procedure' will be followed as per **Rule 36(b)** of Public Procurement Rules 2004 (PPR 2004) available on http://www.ppra.org.pk and is open to all eligible bidders as defined in the PPR 2004 who meet the following minimum eligibility/qualification criteria:
  - a) Bidder must be Original Equipment Manufacturer (OEM) or OEM's Authorized Representative of the High-end Banknote Sorting System with online Shredding, Packaging, Bundling, Shrink Wrap Systems
  - b) Representative must be authorized by OEM specifically for this procurement
  - c) OEM must have Annual Sales Volume/Gross Turnover of at least 10 (ten) million USD or equivalent in any one of last 3 (three) years
  - d) OEM must have Technical Strength of at least 3(three) OEM Certified/Trained Engineers and a Project Manager for this Project
  - e) OEM must prove successful supply, installation, commissioning and maintenance of the offered model to at least 3(three) different central banks/monetary authorities during last 5 (five) years
  - f) OEM shall guarantee availability of Spare Parts/Accessories for at least 15 (fifteen) years from the date of bid submission
  - g) OEM shall ensure to carry out future customization and up gradation of offered machine sensors as per need.
- 4. Technical brochures containing detail specifications of all the components must be provided with the bid. The bidder has to ensure that all the components used for the required supplies are new, genuine and original. Bids proposing substandard, low quality, refurbished or copied items will be rejected. Documentary evidence showing genuineness of brand name, model and country of origin of the product so offered should also be attached.
- 5. All contracts will be signed between the OEM and SBP BSC. The responsibility of execution and compliance of all contracts signed shall rest with the OEM.
- 6. The Bidders are requested to give their best and final prices as no negotiations are expected. The rates quoted must remain valid for a period of **180** (one hundred eighty) days after opening of bids.
- 7. Interested eligible Bidders may obtain further information, if required and purchase the bidding documents on submission of a written application to the address below upon payment of a nonrefundable fee of **PKR10,000**/- (rupees ten thousand only) **or USD100**/-(dollars one hundred only) through bank draft/pay order drawn in favor of **SBP BSC** from the address given below from **9:00 am to 5:30 pm** after publication of IFB till closing thereof. If the bidding documents are requested by post then an additional non-refundable fee of **PKR 5,000**/- (rupees five thousand only) or **USD 50**/- (dollars fifty only) will be required. This IFB is also uploaded for display on the websites http://www.ppra.org.pk and http://www.sbp.org.pk.
- 8. Bid security of not less than 2% (two percent) of the bid price (in same currency of the bid) must be accompanied by Financial Proposal in sealed envelope. Bidders have to submit bids for COMPLETE REQUIREMENTS. Late bids will be rejected. Bids submitted without signed **Bid Form** by authorized nominee of the bidder will be rejected. Bid with material deviation, exception, objection, conditionality, or reservation shall be rejected. Bid found without / insufficient bid security will also be rejected instantly at the time of opening of financial proposals.
- 9. Project Site(s) survey can be conducted before Pre-Bid meeting during working days from **9:00 am to 5:30 pm**. A Pre-Bid Meeting will be held on **Monday, January 19, 2015 at 9:30 am** at SBP's Learning Resource Center, I.I Chundrigar Road, Karachi -Pakistan.
- 10. Bids must be delivered to office of the undersigned on or before **Monday**, **February 23**, **2015**. Bids will be opened in the presence of bidder's representative/s who choose to attend at **11:30** am same day at Learning Resource Centre, State Bank of Pakistan, I.I Chundrigar Road, Karachi –Pakistan.
