INVITATION FOR BIDS (IFB)

Supply/Delivery of Purified Drinking Water at State Bank of Pakistan SBP BSC (Bank) Faisalabad

- 1. The State Bank of Pakistan intends to acquire the services for Supply/Delivery of Purified Drinking Water at SBP-BSC (Bank), Faisalabad.
- 2. Engineering/Procurement Unit of SBP-BSC (Bank), Faisalabad invites sealed bids from eligible bidders for procurement of purified drinking water at SBP-BSC (Bank), Faisalabad as per details mentioned in the bidding documents.
- 3. Bidding will be conducted under National Competitive Bidding pursuant to "Single Stage two Envelopes Procedure" as per Rule 36(b) of Public Procurement Rules 2004 (PPR 2004) and is open to all eligible Bidders as defined in the PPR 2004 that meet the following minimum eligibility criteria.
 - i. Bidders should be registered with Income Tax and Sales Tax department.
 - ii. Bidders should be currently and consistently licensed / approved for at least two years by Pakistan Standards and Quality Control Authority (PSQCA).
 - iii. Bidders should have certification of International Organization of Standardization (ISO) or hazard Analysis or Critical Control Point (HACCP).
 - iv. Should provide copy of test report issued by PSQCA for latest month.
 - v. Should produce documentary evidence of manufacturing and providing purified drinking water for last five 05 years to the organizations (Govt./ Semi Govt./ Private) of comparable stature and strength. The annual volume of sales for last five years should consistently be over PKR 10 Million. Should have liquid assets not less than Rs.3 Million. The bidder must be committed to environmental conservation and must be verified with ISO 14001 for Environmental Management or equivalent.
 - vi. Filling and sealing operations of containers/bottles should be done in aseptic atmosphere. The equipment and its use for production, especially installations for washing and packaging should meet hygienic requirements. Bidders must provide complete details of compliance with regulations governing plant construction and design, sanitary facilities and operations, equipment design and construction production and process controls specific to the processing of bottled drinking water and finished goods inventory management system. The conveyance pipes for various filtration stages should be made of food grade or other acceptable material conforming to relevant standards. Bank may confirm the proffered facts regarding, environmental conservation, origin of water, filtering process, inventory management and distribution through unannounced validation visits.
- vii. Must provide complete details of supply chain, storage facility, number of vehicles in fleet and delivery channels. Delivery fleet should consist of hygienically maintained and covered vans with proper delivery system.
- viii. The water must be supplied in 19 liters hermetically sealed containers made of polythene terephthalate material or the other approved food grade material bottles which shall not cause any undesirable change in taste, color and quality.
- ix. The Bank reserves the right to test the water sample to check the quality of water before awarding the contract and during the contract period at any time, cost of which will be borne by the contractor.
- **4.** Bidders should provide affidavit that the firm /company have never been blacklisted from any Govt., Semi Govt. and Autonomous body.
- **5.** Bidders are requested to give their best and final prices as no negotiations are expected. The rates quoted must remain valid for period of time as mentioned in the bidding documents.
- **6.** All bids must accompany by 02% earnest money of the quoted value. Late bids will be rejected.
- 7. Bids should be submitted with proper sign and stamp by authorized nominee of the bidder. Bids with material deviation, exception, objection, conditionality, or reservation shall be rejected.
- 8. Interested eligible bidders may obtain further information, if required and purchase the bidding documents on submission of a written application to the address below upon payment of a non-refundable fee of Rs.200/- only from Engineering/Procurement Unit, 4th Floor, Jinnah Road, Near GTS Chowk, State Bank of Pakistan SBP BSC (Bank) Faisalabad from 9.00 AM to 5.30 PM before close of business as on 12th Jan, 2015.
