Sealed tenders are invited for the above job from the civil contractors / contracting firms registered with Pakistan Engineering Council at least in Category C-6 with specialization CE-10.

The contractor's / contracting firms are also required to furnish along with their application for issuance of Bidding Documents, the following / information / documentary evidence:

- i. Copy of valid registration certificate with Pakistan Engineering Council.
- ii. Copy of Income Tax Registration Certificate.
- iii. Copies of work orders for two completed jobs of civil / construction works costing at least Rs.1.0 Million during last three years.

Bidding will be conducted under National Competitive Bidding Procedure specified in the Public Procurement Rules 2004 (PPRA-2004) as per Rule -36 (b), under Single Stage and Two Envelopes procedure. Technical and Financial proposals should be submitted in two separate sealed envelopes and be placed in 3rd envelope. The name of the bidder and tender description (Name and technical or financial proposal) shall be clearly marked on all envelope).

The amount of earnest money for the job is 2% of the quoted amount payable in the form as specified in the bidding documents, in favor of NIBAF, Islamabad. Tenders

along with requisite Earnest Money should reach the office of the Joint Director (Administration) National Institute of Banking & Finance, State Bank of Pakistan Pitras Bukhari Road Sector H-8/1 Islamabad on or before September 26, 2014 till 10:00 A.M. Technical Proposals shall be opened in Board Room of NIBAF, Pitras Bukhari Road Sector H-8/1 Islamabad on same date at 10:30 AM in the presence of bidders or their representatives who may like to attend the session. The Financial Proposal of Technically qualified bidders will be opened on date, time and venue communicated to qualified bidders. No tender documents shall be sold on the date fixed for opening of tenders. In case of any unforeseen reasons, public holiday, unrest or force majeure on the bid submission / opening date, the tender shall be opened on the next working day at the same place and time.

Incomplete, conditional and bids without 2% of bid amount as earnest money shall not be considered responsive. All tenders are only invitation to offer and bank reserves the right to accept or reject all tenders as per PPRA rules.
