Sealed Tenders are invited for the above job from the competent Electrical / Mechanical contractors / contracting firms with documentary proof of having completed 3 similar jobs of overhauling express lifts and replacement of faulty parts.

Bidding will be conducted under National Competitive Bidding Procedure specified in the Public Procurement Rules 2004 (PPRA-2004) as per Rule-36(a), <u>under Single Stage</u>, and <u>Single Envelopes procedure</u>. The name of the bidder and tender description shall be clearly marked on all envelopes.

The amount of Earnest Money for the job is 2% of the quoted amount payable in the form of pay order in favor of State Bank of Pakistan, Faisalabad. Tenders along with requisite Earnest Money should be dropped in tender box kept in the office of the PA to Chief Manager at 2nd floor SBP-BSC (Bank) Faisalabad, Jinnah Road, Near GTS Chowk, Faisalabad on or before 26th August, 2014 till 11:00 AM. The Bid shall be opened at office of the Chief Manager, 2nd Floor SBP-BSC (Bank), Jinnah Road, Near GTS Chowk, Faisalabad on same date at 11:30 AM in the presence of bidders or their representatives who may like to attend the session. No tender documents shall be accepted after opening of the tenders. In case of any unforeseen reasons, public holiday, unrest or force majeure on the bid submission/opening date, the tender shall be opened on the next working day at the same place and time.

Incomplete, conditional and bids without 2% of bid amount as earnest money shall not be considered responsive. - 3. Quoted price should be inclusive of all Government taxes, levies etc, as applicable.
- 4. Quoted price should be firm and final and no rebate will be accepted after the opening of quotation.
- 5. Quoted rates should be valid for 90 days.
- 6. Quoted price should be mentioned in words and figures both. In case of error price mentioned in words will be considered as correct.
- 7. Time for the completion of job is 2 months
- 8. Warranty for replaced parts shall be one year from the date of successful commissioning of lift.
- 9. Quantity of the BOQ items may be increased or decreased.
