CONSTRUCTION OF MOSQUE TOILET BLOCK AT STATE BANK OF PAKISTAN SBP BSC (BANK) LAHORE

Sealed Tenders are invited from the contractors / contracting Firms for the above mentioned works. Contractors/ Contracting Firms enlisted with Pak. P.W.D., Provincial P.W.D.s, M.E.S., State Bank of Pakistan or any multinational / well reputed national organizations and having at least 03 years experience of similar works and registered with Pakistan Engineering Council at least in Category C-6 with specialization category CE-10 and Income tax department are eligible to apply.

- 1. The amount of Earnest Money/ Bid Security for the above tender is **2%** of the total bid amount payable in the form Pay Order/Bank Draft/Cash in favour of the State Bank of Pakistan.
- 2. Tender Documents can be obtained from the office of the undersigned at 6th floor Main Building SBP BSC (Bank), Lahore during office hours on working days not later than **10-11-2014** on payment of **Rs. 500/-** (Pak. Rupees five hundred only) as tender fee (non-refundable) in form of cash or pay order in favour of State Bank of Pakistan with written request/application on company letter head. The applicant must have to provide the documentary proof/ evidence of the 03 years experience of similar works and copy of valid PEC and income tax registration certificate while applying for issuance of the Bidding Documents.
- 3. Bidding will be conducted on the basis of National Competitive Bidding method under the provisions of Public Procurement Rules-36(a) single stage, one envelope procedure-(PPRA-2004).
- 4. Tenders should be dropped in the Tenders Drop Box kept in the office of the PA to Currency Officer at 3rd Floor, SBP BSC Mall Road, Lahore, by or before the date fixed for submission of Bids i.e. 11-11-2014 till 11:00 AM. Bids shall be opened on the same date at 11:30 AM in the presence of Bidders or their authorized representatives who will like to be present.
- 5. Tender of a bidder shall be cancelled if the bidder is found blacklisted by any organization at any stage during tendering process or execution of the Contract.
- 6. The bid of any bidder shall be declared non-responsive if he is found involved in litigation with any government or semi-government department.

- 7. If any clarification is required, the query may be sent to the undersigned through registered courier, e-mail or fax, at least **07** days prior to the date fixed for submission of bids. All replies to the queries or addendum etc. shall be considered part of the tender documents and should be signed and submitted along with the bid.
- 8. In case of any unforeseen reasons, unrest or force majeure on the bid submission/opening date, the tender shall be opened on the next working day at the same place and time.
- 9. The Bids shall remain valid for a minimum period of **90** days from the date fixed for submission of the Bids.
- 10. Incomplete, conditional and tenders without appropriate earnest money shall not be considered.
- 11. These tenders are only invitation to offer and Bank does not bind itself to accept the lowest or any tender as per PPRA rules.
- 12. Further, personal canvassing, recommendation or unauthorized practices for getting the Contract, will also disqualify the bidders.
