**SUPPLY OF LUBRICATING OIL & FILTERS FOR 900 KVA CUMMINS DIESEL GENERATOR SET  
INSTALLED AT SBP BSC (BANK) LAHORE**

Sealed Tenders are invited from the contractors / contracting Firms for the above mentioned works. Contractors/ Contracting Firms having experience of similar type of supplies are eligible to apply along with complete profile and work experience supported by documentary evidence.

1. The amount of Earnest Money for the above tender is **2%** of the total bid amount payable in the form of Cash/Bank Draft/Payment Order in favor of the State Bank of Pakistan SBP BSC (Bank), Lahore.
2. Tender Documents can be obtained from the office of the undersigned at 6<sup>th</sup> Floor, SBP BSC (Bank), Mall Road, Lahore during office hours on working days not later than **14.02.2014** with written request/application on company letter head.
3. Bidding will be conducted on the basis of National Competitive Bidding method under the provisions of Public Procurement Rule-36(a) single stage, one envelope procedure-(PPRA-2004).
4. Sealed tenders should be dropped in the Tenders Drop Box kept at the office of the Currency officer **3<sup>rd</sup> Floor, SBP BSC (Bank), Mall Road, Lahore** by or before the date fixed for submission of Bids i.e. **17.02.2014** till **11:00 AM**. Bids shall be opened on the same date at **11:30 AM** in the presence of Bidders or their authorized representatives who will like to be present.
5. Tender of a bidder shall be cancelled if the bidder is found blacklisted by any organization at any stage.
6. The bid of any bidder shall be declared non-responsive if he is found involved in litigation with any government or semi-government department.
7. In case of any unforeseen reasons, unrest or force majeure on the bid submission/opening date, the tender shall be opened on the next working day at the same place and time.
8. The Bids shall remain valid for a minimum period of **90** days from the date fixed for submission of the Bids.
9. Contractor may visit the site before quoting the rates.

10. Incomplete, conditional and tenders without appropriate earnest money shall not be considered.
11. These tenders are only invitation to offer and Bank does not bind itself to accept the lowest or any tender as per PPRA rules.
12. Further, personal canvassing, recommendation or unauthorized practices for getting the Contract, will also disqualify the bidders.
