## SUPPLY OF LUBRICATING OIL & FILTERS FOR 900 KVA CUMMINS DIESEL GENERATOR SET INSTALLED AT SBP BSC (BANK) LAHORE

Sealed Tenders are invited from the contractors / contracting Firms for the above mentioned works. Contractors/ Contracting Firms having experience of similar type of supplies are eligible to apply along with complete profile and work experience supported by documentary evidence.

- The amount of Earnest Money for the above tender is 2% of the total bid amount payable in the form of Cash/Bank Draft/Payment Order in favor of the State Bank of Pakistan SBP BSC (Bank), Lahore.
- Tender Documents can be obtained from the office of the undersigned at 6<sup>th</sup> Floor, SBP BSC (Bank), Mall Road, Lahore during office hours on working days not later than 14.02.2014 with written request/application on company letter head.
- 3. Bidding will be conducted on the basis of National Competitive Bidding method under the provisions of Public Procurement Rule-36(a) single stage, one envelope procedure-(PPRA-2004).
- 4. Sealed tenders should be dropped in the Tenders Drop Box kept at the office of the Currency officer 3<sup>rd</sup> Floor, SBP BSC (Bank), Mall Road, Lahore by or before the date fixed for submission of Bids i.e. 17.02.2014 till 11:00 AM. Bids shall be opened on the same date at 11:30 AM in the presence of Bidders or their authorized representatives who will like to be present.
- 5. Tender of a bidder shall be cancelled if the bidder is found blacklisted by any organization at any stage.
- 6. The bid of any bidder shall be declared non-responsive if he is found involved in litigation with any government or semi-government department.
- 7. In case of any unforeseen reasons, unrest or force majeure on the bid submission/opening date, the tender shall be opened on the next working day at the same place and time.
- 8. The Bids shall remain valid for a minimum period of <u>90</u> days from the date fixed for submission of the Bids.
- 9. Contractor may visit the site before quoting the rates.

- 10. Incomplete, conditional and tenders without appropriate earnest money shall not be considered.
- 11. These tenders are only invitation to offer and Bank does not bind itself to accept the lowest or any tender as per PPRA rules.
- 12. Further, personal canvassing, recommendation or unauthorized practices for getting the Contract, will also disqualify the bidders.
