**TENDER NOTICE**

**SUPPLY, INSTALLATION, TESTING AND COMMISSIONING OF POWER FACTOR IMPROVEMENT  
PLANT AT SBP BSC – SUKKUR OFFICE**

1. State Bank of Pakistan, SBP-BSC invites sealed Tenders from the Contractors/ Contracting firms who are Tax registered and enlisted with Pak. P.W.D./M.E.S/Quasi Government Body/Pakistan Engineering Council/State Bank of Pakistan, or any reputed organization, shall be eligible to participate in the tender.
2. Bidding shall be conducted using National competitive bidding procedures as specified in the Public Procurement Rule (PPRA-2004)-36 (a) based on single stage **ONE** Envelope Procedure. The name of the Bidder and Tender description shall be clearly marked on the envelope separately.
3. Bidders are requested to give their best & final prices as no negotiations are expected. The rates quoted should be valid for a period of **120 days** from the date of bid opening. Interested Bidders may collect the bidding documents from the office at given address office of the Chief Manager State Bank of Pakistan, SBP-BSC (BANK) Sukkur and office of the Head, Engineering Department, State Bank of Pakistan, SBP-BSC, 1<sup>st</sup> floor, Boulton Market Building, M.A. Jinnah Road, Karachi on submission of written request/application along with Demand Draft/Pay Order/Cash of **Rs.500/-** (non-refundable) fees. The quantity/volume of work may increase or decrease, item of work may be added or deleted as per site/Bank's conditions and requirements. Bidders must have documented track of completing similar assignments/ work of similar functional/technical characteristics of a comparable scale.
4. The amount of Earnest Money (refundable) for the above tender is not less than 2% of total bid cost in the shape of Bank Draft/Payment Order /Call Deposit in favor of State Bank of Pakistan, SBP-BSC, Sukkur should be accompanied with the quotation, to be submitted in a sealed cover duly named, signed, **e-mail address** & subject boldly marked on the envelope shall be dropped either personally or sent through Registered Post/Couriers so as to reach the office of the Chief Manager State Bank of Pakistan, SBP-BSC, Sukkur on or before on **Thursday, 14-4-2014, at 03:00 P.M.** Tender will be opened on the same date at **03:30 P.M** in the presence of Bidders/Tenderers who may like to be present.
5. The Bank is not under any obligation to accept the lowest Bid and reserves the right to select /reject any or all the Bid(s) as per PPRA rules. Tender submitted after the scheduled time of opening shall not be entertained and shall be returned straightaway. Each tender will be evaluated separately and work shall be awarded to only **ONE** lowest evaluated responsive bid among the bids altogether.
6. Conditional, optional, incomplete bid and Tender without or less than 2% Earnest Money of total final bid amount and not fulfilling the above mentioned requirements, shall be considered as **Non-Responsive**.
7. Further, personal canvassing or recommendations will also disqualify the Bidder. Bid not submitted on Bank's prescribed format/BOQ will be rejected. No Tender document shall be sold on the date fixed for opening of the tender.
