- 1) The amount of Earnest Money/ Bid Security for the above tenders are **2%** of the total bid amount for respective tender no. payable in the form of Pay Order/Bank Draft (cash not acceptable) in favour of the State Bank of Pakistan.
- 2) Tender Documents can be obtained from the engineering division office at 6th floor Main Building SBP BSC (Bank), Lahore during office hours on working days not later than one day before date of submission of bids as mentioned in the above table on payment of **Rs. 500/-** (Pak. Rupees five hundred only) for each Tender as tender fee (non-refundable) in form of cash or pay order in favour of State Bank of Pakistan with written request/application on company letter head. The contractors/ contracting firms are also required to furnish along with their application on company letter head for issuance of Bidding Documents, the following information/ documentary evidence;

- a) Copy of valid registration certificate with Pakistan Engineering Council in the category C4, CE-10 for **Tender # 1** and/or **Tender # 2** and/or **Tender # 3**.
- b) Copy of Income Tax Registration Certificate.
- 3) Bidding will be conducted on the basis of National Competitive Bidding method under the provisions of Public Procurement Rule-36(a), under *Single Stage, and One Envelopes* procedure.
- 4) The name of the bidder and tender description (Tender No. and Name of Work) shall be clearly marked on all envelopes for **Tender # 1** and/or **Tender # 2** and/or **Tender # 3**.
- 5) No Tender Documents shall be sold on the date fixed for opening of the Tender.
- 6) Tenders should be dropped in the Tenders Drop Box kept in the Office of the PA to Currency Officer at 3rd Floor, SBP BSC Mall Road, Lahore, by or before the date fixed for submission of Bids as per above detail. Tender shall be opened on the dates as per above details in the presence of Bidders or their authorized representatives who may like to attend the session.
- 7) Tender of a bidder shall be cancelled if the bidder is found blacklisted by any organization at any stage during tendering process or execution of the Contract.
- 8) The bid of any bidder shall be declared non-responsive if he is found involved in litigation with any government or semi-government department.
- 9) If any clarification is required, the query may be sent to the undersigned through registered courier, e-mail or fax, at least **07** days prior to the date fixed for submission of bids. All replies to the queries or addendum etc. shall be considered part of the tender documents and should be signed and submitted along with the bid.
- 10) In case of any unforeseen reasons, unrest or force majeure on the bid submission/opening date, the tender shall be opened on the next working day at the same place and time.
- 11) The Bids shall remain valid for a minimum period of **90** days from the date fixed for submission of the Bids.
- 12) Incomplete, conditional and tenders without required earnest money shall not be considered.
- 13) These tenders are only invitation to offer and Bank does not bind itself to accept the lowest or any tender as per PPRA rules.
- 14) Further, personal canvassing, recommendation or unauthorized practices for getting the Contract, will also disqualify the bidders.
