

**TENDER NOTICE**

**Supply of Engineering Store Items**

at

**State Bank of Pakistan SBP BSC (BANK) RAWALPINDI**

1. Sealed Bids are invited from the eligible suppliers registered with Sales Tax & Income Tax Departments, for the supply & delivery of "Engineering Store Items" as per given in the Bidding Documents. Firms engaged in the supply of similar items for at least 03 years are eligible to apply.
2. ***Copies of NTN and GST registration certificate shall have to be presented along with the application for issuance of bidding Documents.***
3. The amount of Earnest Money/Bid Security for the above tender is 2% of the total bid amount payable in the form as specified in the Bidding Documents in favor of the SBP BSC (Bank) Rawalpindi.
4. Tender Documents can be obtained from the office of the undersigned at SBP BSC (Bank), 2<sup>nd</sup> Floor, The Mall, Rawalpindi during office hours on working days not later than **05.05.2014** on payment of specified tender fee (non-refundable) of **PKR 200/- (Two hundred rupees) in the form of Pay Order/CDR**, with written request/application on company letter head and copies of documents required as per para-2 above).
5. Bidding will be conducted under National Competitive Bidding Procedure as per the provisions of Public Procurement Rules-36(a) single stage-one envelope procedure-(PPRA-2004).
6. Bids should be dropped in the Tenders Drop Box kept in the office 1<sup>st</sup> Floor, SBP BSC (Bank) Rawalpindi, by or before the **06.05.2014 till 11:00 AM**. The Bids shall be opened on the same day at **11:30 AM** in the presence of the Bidders or their authorized representatives who may like to be present during the session.
7. Bid of any bidder shall be cancelled if the bidder is found blacklisted by any organization at any stage during tendering process or execution of the Contract.
8. If any clarification is required, the query may be sent to the undersigned through registered courier, e-mail or fax, at least **07** days prior to the date fixed for submission of bids. All replies to the queries or addendum etc. shall be considered part of the bidding documents and should be signed and submitted along with the Bid.
9. In case of any unforeseen reasons, unrest or force majeure on the bid submission/opening date, the tender shall be opened on the next working day at the same place and time.
10. The Bids shall remain valid for a minimum period of **90** days from the date fixed for submission of the Bids.
11. Incomplete, conditional and Bids without appropriate earnest money shall not be considered.
12. These tenders are only invitation to offer and Bank does not bind itself to accept the lowest or any Bid as per PPRA rules.
13. Further, personal canvassing, recommendation or unauthorized practices for getting the Contract, will also disqualify the bidders.
