Sealed Tenders are invited for the above job from the Electrical/ Sound System contractors/ contracting firms having specialization of works mentioned in BOQ.

Complete set of tender documents, specifications and drawings can be obtained from the office of the undersigned at **1<sup>st</sup> floor, SBP Bolton Market Office Building, M.A Jinnah Road, Karachi**, against payment of **Rs.500/- (Rupees five Hundred only)** in form of pay order (Non Refundable) as Tender fee. The contractors /contracting firms are also required to furnish along with their application for issuance of Bidding documents, the following information/documentary evidence:

Bidding will be conducted under national competitive Bidding procedure specified PPRA-2014 as per rule-36(a) under single stage, and single envelope procedure. The name of the bidder and tender description (Name and technical or financial proposal) shall be clearly marked on envelope.

The amount of Earnest money for the job is **2%** of the quoted amount payable in the form as specified in the bidding documents, in favor of State Bank of Pakistan. Tender along with requisite earnest money should be dropped in tender box kept in the office of the PA to Director Engineering at 1<sup>st</sup> floor, BP Bolton Market Office Building Karachi, or on before **November 25, 2014 till 03:00PM**. Bids shall be opened at office of the Engineering Department 1<sup>st</sup> floor, SBP Bolton Market Office Building Karachi, on same date at **03:30PM** in the presence of bidders or their representatives who may like to attend the session. No tender documents shall be sold on the date fixed for opening of the tenders. In case of any unforeseen reasons, public Holiday, unrest or force majeure on the bid submission/opening date, the tender shall be opened on the next working day at the same place and time.

Incomplete, conditional and bids without 2% of bid amount as earnest money shall not be considered responsive. These tenders are only invitation to offer and Bank does not bind itself to accept the bids as per PPRA rules. Further, personal canvassing, recommendation or unauthorized practices for getting the contract, will also disqualify the bidders. Further details are provided in the bidding documents.
