TENDER NOTICE SUPPLY & INSTALLATION OF 08 SPLIT AIR CONDITIONERS AT STATE BANK OF PAKISTAN BANKING SERVICES CORPORATION, ISLAMABAD.

State Bank of Pakistan, SBPBSC (Bank), Islamabad hereby invites sealed bids from Manufacturers/ Authorized Distributors / Agents and tax registered eligible bidders for the above mentioned work. Bidding will be conducted using the National Competitive Bidding procedures specified in the Rule 36 (a) of Public Procurement Rules 2004 (PPR 2004) "**single stage single envelope procedures**" and is open to all eligible Bidders as defined in the PPR2004 that meet the following minimum qualification criteria:

"Bidders must be a Manufacturer or Authorized Distributor of the manufacturer required equipment in Pakistan with a minimum of 5 (five) years of experience in manufacturing or as an Authorized Distributor/agent, as applicable. Agent should be in possession of a consistently valid Authorization Certificate for at least 5 five years. Manufacturer/Supplier should have a documented track of completing at least three (3) similar assignments, during last five (5) years. Bidder must be registered with Income Tax and Sales Tax Department copy of certificates should be enclosed along with bid".

Technical brochure containing detailed specifications must be provided with the bid. The bidder must mention brand name, model and country of origin of the offered product. Documentary evidences showing genuineness of brand names, model and country of origin of the product so offered. If the product is assembled in a country other than the country of origin, in that case the bidder shall provide certification from the parent company to the satisfaction of the purchaser that the product is being assembled under license of the principal manufacturer and that the manufacturer stands guarantee to the quality of the material, workmanship and performance.

All Bids must accompany a bid security of not less than 2% of the bid price payable in shape of Bank Draft/Payment Order /Call Deposit in favor of State Bank of Pakistan, SBP-BSC (Bank), Islamabad. Late bids will be rejected. Bids submitted with unsigned Bid Form by authorized nominee of the bidder will also be rejected. The Bank reserves the right to select /reject the Bid(s) as per PPRA rules.

Interested eligible bidders may acquire further information, technical specifications and obtain the bidding documents without any charges on the submission of a written application to the address mentioned below. Bidders are requested to give their best & final prices as no negotiations are expected after bidding. The rates quoted should be valid for a period of at least 90 days from the bid opening date.

Bids must be delivered to the address below on or before **11.00** hours on **Monday, May 26, 2014**. Bids will be opened in the presence of bidders' representatives who choose to attend at **11:30** hours on the same day at State Bank of Pakistan – SBPBSC (Bank), Islamabad.
