### **SUPPLY OF WALL MOUNTED 20 X 1.5 TONS SPLIT AC UNITS WITH INVERTER TECHNOLOGY AT MAIN ENGINEERING STORE, SBP KARACHI**

Sealed Tenders are invited on the prescribed form in Single Stage single envelop procedure as per Public Procurement Rules 2004 under Rule 36(a) for the above work from Sales and Income Tax registered Authorized Agents of Manufacturers /Suppliers.

Bidding will be conducted using the National Competitive Bidding Procedures specified in the Public procurement Rules 2004 and open to all eligible bidders as defined in the PPR-2004 that meet the following minimum qualification criteria.

Bidders must be a Manufacturer or Authorized agent of manufacturer.

Bidders must have a documented track of completing at least 3- 5 similar assignments, during last 3 (three) years, of similar functional / technical characteristics and of a comparable scale.

Bidders are requested to give their best final prices. The rates quoted must remain valid for a period of 30 days after opening of quotations. The Bid will be evaluated as per the evaluation criteria mentioned in the tender documents. All quotations must be accompanied by a bid security of not less than 2% of the quoted price. Quotations not submitted on prescribed format will be rejected.

The interested contractor/Firm shall apply for the issuance of tender documents along with their complete company profile/resume with the details of works of similar nature presently in hand and executed during last three years with cost supported by the documentary evidence. The tender document can be obtained from the office of the undersigned on payment of Rs.2000/- in cash (Non refundable) during office hours on any working day.

No tender documents shall be issued on the date fixed for opening of the tenders. Incomplete, conditional, and tender without specified amount of earnest money shall not be accepted.

The sealed tender documents should be dropped in the Tender Box kept with the P.A. to Director Engineering, State Bank of Pakistan, BSC (Bank), 1st floor Bolton Market Building, M.A. Jinnah Road, Karachi by **03.00 P.M.** on **23-9-2014**. The tenders will be opened on the same day at **03.30 P.M.** in the presence of contractors who may like to be present. Further personal canvassing or recommendations or unauthorized practices for getting the contract will also disqualify the bidders.
