INVITATION TO BID

**CONSULTANCY SERVICES FOR OVERHAULING & REPAIRING OF FIRE FIGHTING SYSTEM AT
MAIN BUILDING, CANTEEN BUILDING, LRC & BOLTON MARKET BUILDING**

State Bank of Pakistan BSC intends to engage a consultancy firm for overhauling & repairing of fire fighting system at SBP Main Building, BSC House (Canteen Building), SBP LRC Building and Bolton Market Building, Karachi. Sealed Tenders are invited for the purpose from the consultancy firms registered with Pakistan Engineering Council as a consulting firm. The firms having carried out at least three (03) such jobs under a single consultancy value of Rs.1.0 Millions each during last five (05) years in any Government/ Semi-Government body or any well known private organization are eligible to apply.

Bidding will be conducted under National Competitive Bidding Procedure specified in "Procurement of Consultancy Services Regulations, 2010" of PPRA under Single Stage and Two Envelopes procedure. Complete set of standard bidding documents can be obtained from the office of the undersigned located at 1st Floor, SBP Bolton Market Office Building, and M.A Jinnah Road, Karachi against payment of Rs. 1,000 /- in form of Pay Order / cash (Non-Refundable) as bid fee. The consultants/ consulting firms are also required to furnish along with their application for issuance of Bidding Documents, the following information/ documentary evidence;

- i. Copy of valid registration certificate as a consulting firm with Pakistan Engineering Council.
- ii. Copy of Income Tax/ Professional Tax Registration Certificate.
- iii. Copies of Works Orders or completion certificates for three (03) similar jobs performed during last five (05) years with verifiable contact details.

The technical and financial proposals should be sealed in two separate envelopes and be placed in 3rd sealed envelope. The name of the bidder and tender description (Name and technical or financial proposal) shall be clearly marked on all envelopes. Tender should be dropped in tender box kept in the office of the PA to Director Engineering at 1st floor SBP Bolton Market Office Building, M.A. Jinnah Road, Karachi as mentioned above. Tenders should reach to the undersigned on or before **08.09.2014** till **03:00PM**. The Technical Proposals shall be opened on same date at **03:30PM** in the presence of bidders or their representatives who may like to attend the session. No tender documents shall be sold on the date fixed for opening of the tenders. In case of any unforeseen reasons, unrest or force majeure on the bid submission/opening date, the tender shall be opened on the next working day at the same place and time. After the evaluation & approval of the Technical Proposals, Financial Proposals of the technically responsive bids shall be publicly opened at a time, date and venue, communicated to the qualified bidders in advance.

The Bids shall remain valid for a minimum period of 120 days from the date fixed for submission of the Bids. Incomplete and/or conditional shall not be considered responsive. This Tender Notice is only an invitation to offer and Bank does not bind itself to accept the lowest or any bid as per PPRA Rules. Further personal canvassing, recommendation or unauthorized practices for getting the Contract, will also disqualify the bidders. The bidders are requested to quote their best and final rates as no post tender negotiations are expected.
