3. Bidding will be conducted using the Negotiated Tendering procedures in accordance with Rule 42 d (ii) Public Procurement Rules 2004 (PPR 2004) and is open to all eligible Bidders as defined in the PPR 2004 that meet the following minimum eligibility/qualification criteria:

- Bidders must be a Manufacturer (OEM) or an authorized Agent /Partner of the OEM of required software in Pakistan*
- Bidder must be registered with Income and Sales Tax Department.*

4. Bidders will submit quotations of **COMPLETE REQUIREMENT**, evaluation of bid and contract award will be done accordingly.

5. The Bidders are requested to give their best and final prices as no negotiations are expected. The rates quoted must remain valid for a period of **ninety days (90)** after opening of tenders.

6. All bids must be accompanied by a Bid Security of not less than **2%** of the bid price. Bid found without / insufficient earnest money will be rejected. Late bids will be rejected. Bids submitted without signed Bid Form by authorized nominee of the bidder will also be rejected. Bid with material deviation exception, objection, conditionality, or reservation; shall also be rejected.
