**SUPPLY OF FOUR TON CAPACITY FLOOR STANDING
SPLIT TYPE AC UNITS AT STATE BANK OF PAKISTAN-BSC, SUKKUR**

Sealed Tenders are invited from the Manufacturers/Authorized Distributors/Agent also registered with Sales Tax and Income Tax Department for the above mentioned work.

Bidding will be conducted using the National Competitive Bidding Procedures specified in the Public procurement Rules 2004 "single stage single envelop procedures" and is open to all eligible bidders as defined in the PPR-2004 that meet the following minimum qualification criteria.

Bidders must be a Manufacturer or Authorized Distributor/agent of the manufacturer required equipment in Pakistan with a minimum of 5 (five) years of experience in manufacturing or as an Authorized Distributor/agent, as applicable. Agent should be in possession of a consistently valid Authorization Certificate for at least 5 five years. Manufacturer/Supplier should have a documented track of completing at least three (3) similar assignments, during last five (5) years. Bidder must be registered with Income Tax and Sales Tax Department copy of certificates should be enclosed along with bid. Technical brochure containing detailed specifications must be provided with the bid. The bidder must mention brand name, model and country of origin of the offered product. Documentary evidences showing genuineness of brand names, model and country of origin of the product so offered. If the product is assembled in a country other than the country of origin, in that case the bidder shall provide certification from the parent company to the satisfaction of the purchaser that the product is being assembled under license of the principal manufacturer and that the manufacturer stands guarantee to the quality of the material, workmanship and performance. The tender document can be obtained from the office of the undersigned on payment of Rs.2000/- in cash, payment order & Bank draft (Non refundable) during office hours on any working day.

The amount of Earnest Money is 2% of total amount payable in the form as specified in the tender documents. No tender documents shall be issued on the date fixed for opening of the tenders. Incomplete, conditional, and tender without required amount of earnest money shall not be accepted. This tender is only an invitation to offer and the bank does not bind itself to accept the lowest or any tender and also reserve the rights to reject any/all tenders as per PPRA Rules. The tender will be evaluated on basis of evaluation criteria mentioned in the tender documents. The Bank reserves the rights to decrease/increase the quantity.

The tender should be dropped in the sealed Tender Box kept with the Assistant Chief Manager, (GSU) State Bank of Pakistan, BSC (Bank), Sukkur, by **03.00 P.M.** on **January 30, 2015**. The tenders will be opened on the same day at **03.30 P.M.** in the presence of the contractors who may like to be present. Further personal convincing or recommendations or unauthorized practices for getting the contract will also disqualify the bidders.

In case of any unforeseen reasons, unrest or force majeure on the bid submission/opening date the quotations will be opened on the next working day at the same place and time.
