



## **Invitation for Bids (IFB)**

### **State Bank of Pakistan (SBP BSC)**

1. The State Bank of Pakistan (SBP) intends to acquire Maintenance and Support Services for its in use AVAYA IP PABX System.
2. Procurement Division, General Services Department (SBP BSC) on behalf of State Bank of Pakistan invites sealed bids from eligible Bidders for “**Maintenance and Support Services for Avaya IP PABX System at SBP**” for a period of **03 (three) years** as detailed in the bidding documents.
3. Bidding will be conducted under Negotiated Tendering procedure in accordance with Rule 42 d (ii) of Public Procurement Rules 2004 and is open to all eligible Bidders as defined in the PPR-2004 who meet the following minimum eligibility/qualification criteria:-
  - a. *Bidders must be a manufacturer (OEM) or an authorized agent/dealer/partner of the manufacturer in Pakistan with a currently valid authorization certificate of OEM*
  - b. *Bidders must have at least two (02) OEM Certified /Trained Engineers/Technicians*
  - c. *Bidder must be registered with Income Tax and Sales Tax Departments.*
4. Bidders will quote for COMPLETE REQUIREMENT, evaluation of bids and contract award will be done accordingly.
5. The Bidders are requested to give their best and final prices as no negotiations are expected. The rates quoted must remain valid for a period of one hundred twenty (**120**) days after opening of the bids.
6. All bids must be accompanied by a Bid Security of not less than **2%** of the bid price. Bid found without / insufficient bid security will be rejected. Late bids will be rejected. Bids submitted without signed Bid Form by authorized nominee of the bidder will also be rejected. Bid with material deviation exception, objection, conditionality, or reservation; shall also be rejected.
7. Interested eligible Bidders may obtain further information and obtain the bidding documents without any charges on submission of a written application to the address mentioned below. IFB is also uploaded for display on the websites <http://www.ppra.org.pk> and <http://www.sbp.org.pk>.
8. Bids must be delivered to the address below on or before **Tuesday, March 10 2015 at 1100 Hours**.
