Sealed Tenders are invited from the contractors / contracting Firms for the above mentioned civil works enlisted with Pak. P.W.D., Provincial P.W.D.s, M.E.S., State Bank of Pakistan or any multinational / well reputed organizations having at least five years experience of similar works, registered with income tax department & PEC are eligible to apply.

- 1. The amount of Earnest Money for the above tender is **2**% of the total bid amount payable in the form as specified in the Bidding Documents in favor of the State Bank of Pakistan.
- Tender Documents can be obtained from the office of undersigned at Old Building, SBP BSC, Kutchery Road, Sialkot, during office hours on working days not later than 27th July 2015 on payment of Rs. 500/- (Pak. Rupees Five hundred only) as tender fee (non-refundable) with written request/application on company letter head along with following documentary evidence;
 - (a) Copy of Income Tax Registration Certificate.
 - (b) Copies of work orders or completion certificates for three completed similar jobs amounting to Rs. 01 Million or above during last five years.

- 4. Bidding will be conducted on the basis of National Competitive Bidding method under the provisions of Public Procurement Rule-36(a) single stage, one envelope procedure-(PPRA-2004).
- 5. Sealed tenders should be dropped in the office of the DCM Admin, Main Building, SBP BSC, Kutchery Road, Sialkot, by or before the date fixed for submission of Bids. Bids shall be opened in the presence of Bidders or their authorized representatives who like to be present. Bidder and project name shall be clearly marked on sealed envelope.

- 6. Tender of a bidder shall be cancelled if the bidder is found blacklisted by any organization at any stage during tendering process or execution of the Contract.
- 7. The bid of any bidder shall be declared non-responsive if he is found involved in litigation with any government or semi-government department.
- 8. If any clarification is required, the query may be sent to the undersigned through registered courier, e-mail or fax, at least **07** days prior to the date fixed for submission of bids. All replies to the queries or addendum etc. shall be considered part of the tender documents and should be signed and submitted along with the bid.
- 9. In case of any unforeseen reasons, unrest or force majeure on the bid submission/opening date, the tender shall be opened on the next working day at the same place and time.
- 10. The Bids shall remain valid for minimum period of <u>90</u> days from the date fixed for submission of the Bids.
- 11. Incomplete, conditional and tenders without appropriate earnest money shall not be considered.
- 12. These tenders are only invitation to offer and Bank does not bind itself to accept the Bids as per PPRA rules.
- 13. The Employer reserves the right to increase/decrease the quantities or delete any item mentioned as per the requirements.
- Further, personal canvassing, recommendation or unauthorized practices for getting the Contract, will also disqualify the bidders.
