5. No Tender Documents shall be issued on the date fixed for opening of the same Tender.
6. The earnest money should not be less than 2% of the total quoted rates in the shape as provided in tender documents in favour of State Bank of Pakistan should be submitted with the tender(cash will not be accepted).
7. Incomplete, conditional and tenders without or less earnest money in the specified form/format shall be rejected.
8. Tender should be dropped in tender box kept in the office of the PA to Director Engineering at 1<sup>st</sup> floor SBP Bolton Market Building, M.A. Jinnah Road, Karachi as per the detail mentioned in the above table.
