- Bidding shall be conducted according to the National Competitive Bidding Procedure specified in 36 (a) of PPRA Rules 2004i.e. Single Stage Single Envelope method. which is permissible for all eligible bidders that meet the minimum qualification criteria mentioned in the tender documents.
- Tender shall be submitted in accordance with the Schedule of Prices, Specifications and other provisions of the tender documents provided to the intended bidders. Bids shall be evaluated on the basis of Bid evaluation criteria (BEC) given in the Tender Documents, however in case of non compliance of BEC bid will be declared as Non Responsive.
- The rates quoted should be in specified format of the tender and valid for a minimum period of **60 days** from the date of submission of Bid.
- Prescribed tender documents can be obtained from the Office of the under signed during office hours up to **18<sup>th</sup> october,2015** at 1<sup>st</sup> floor SBP Sub- Office Building opposite Bolton Market, Karachi on payment as mentioned in the above schedule against Cash / Pay Order / Demand Draft (non-refundable) in favor of State Bank of Pakistan & on production of Request Letter on Company's Letter Head and copy of Sales Tax Certificate, Income Tax Certificate, and Company's Profile on any working day/timings.
- The earnest money should not be less than 2% of the total quoted amount** in shape of pay order (**cash will not be accepted**) in favour of State Bank of Pakistan should be submitted with the tender.
- Incomplete, conditional and tenders without earnest money in the specified form/format shall be rejected.
- Tender should be dropped in tender box kept in the office of the PA to Director Engineering at 1<sup>st</sup> floor SBP Bolton Market Building, M.A. Jinnah Road, Karachi as per the detail mentioned in the above table.
