

Invitation for Bids (IFB)

State Bank of Pakistan, Banking Services Corporation, Head Office Karachi intends to acquire maintenance and technical support services for its existing Security related Equipment.

2. Procurement Division, General Services Department, on behalf of Internal Banks Security Department (SBP BSC) invites sealed bids for "Procurement of Services of Contractors / Firms for maintenance & Support Services of Security Equipment installed at Buildings of State Bank of Pakistan & SBP Banking Services Corporation, Head Office, Karachi and its Field Offices situated across Pakistan" as per details provided in the Bidding documents for a period of 3 years as per PPR-2004. Bidding will be conducted under National Competitive Bidding pursuant to "Single stage two envelops procedure as per Rule 36(b) of Public Procurement Rules-2004 and is open to all eligible tax registered Contractors / Firms who are on Active Taxpayers List (ATL) of FBR with verifiable presence / support/ branch offices at least in 3 major cities e.g. Karachi, Lahore & Islamabad/Rawalpindi and having no history of termination / blacklisting on service related issues. Further, the minimum eligibility qualification / criteria for each package is as follows:-

Package-1	UVI System, IP Cameras, CCTV Cameras with Controller, DVR (Surveillance System) CCTV Monitors	i.	The bidders should have at least three (3) years' experience of providing maintenance and Support Service for Security Equipment to large organizations of comparable scale and stature.
Package-2	Anti Burglary Alarm System, Central Security Alarm System & Fire Detection/ Alarm System	ii.	The bidders should have adequate number of trained staff/ technicians capable to handle/repair all types of Security Systems.

Package-4	Baggage Scanner Machines	i. ii.	The bidders must hold valid license issued by Pakistan Engineering Council / Pakistan Nuclear Regulatory Authority (Only for Package-4) The bidders must be direct authorized agent of the manufacturer for supply, maintenance & support services of required equipment in Pakistan. Agent should be in possession of a consistently valid OEM's Authorization Certificate for last two (2) years.
Package-5	Walk through Gates	iii. iv.	The bidder must have experience of at least two (2) assignments of maintenance and Support Service of same or higher rated equipment during last three (3) years. The bidder's experience as sub-contractor will also be acceptable. The bidder must have technical strength of at least three (3) OEM trained /certified Engineers or Technicians for relevant equipment.

- 3. The rates quoted must remain valid for a period of One hundred twenty (120) days after opening of the bids. Bid security of 2% of the bid price must be accompanied by Financial Proposal in sealed envelope. Late bids will be rejected. Bids submitted without signed Bid Form by authorized nominee of the bidder will be rejected. Bid with material deviation, exception, objection, conditionality or reservation shall be rejected. Bid found without earnest money will also be rejected instantly at the time of opening of financial proposals.
- 4. Eligible and qualified bidders can submit bids for ALL or for INDIVIDUAL Package of Equipment(s). Separate contracts will be signed for each Package. Bidders will have to comply with COMPLETE REQUIREMENTS for the quoted Package(s).
- 5. Interested eligible Bidders may obtain further information, if required and purchase the bidding documents on submission of a written application, upon payment of a nonrefundable fee of Rs.1,000/- (Rupees one thousand only) through Pay Order /Bank Draft drawn in favor of **SBP BSC** from the address given below from 9:00 am to 5:30 pm after publication of the IFB till closing thereof. A non-refundable fee of Rs.1,500/- (Rupees one thousand five hundred only) will be charged if the bidding documents are requested by post. - 6. A pre-bid meeting will be held on November 5, 2015 at 11:00 am at Learning Resource Centre, State Bank of Pakistan, I.I. Chundrigar Road, Karachi.
