- 2. Bidding will be conducted under National Competitive Bidding pursuant to "Single stage two envelope procedure" as per Rule 36(b) of Public Procurement Rules 2004 (PPR 2004) and is open to all eligible bidders as defined in the PPR 2004 who meet the following minimum eligibility/qualification criteria:
  - a. Bidder must be a Manufacturer/Direct authorized agent of OEM to deal/market the Hydraulic Road Blocker;
  - b. The bidder should have an annual turnover of `PKR 25 Million' in any one of the last three financial years;
  - c. The bidder should have at least three (03) years experience of supply and installation of heavy duty road blocker to large organizations of comparable scale and stature.
  - d. The Bidder must show that it has qualified technical support to be able to carry out the above equipment's repair and maintenance and spare parts-stocking obligations as prescribed in the conditions of Bidding documents/Technical specifications.
  - e. The Bidder must be registered with Income and Sales Tax Department.
- The bidders must quote of equipment, meeting the technical specifications required by the Bank.
  Technical brochure containing detailed specifications of the said item should be provided with the
  bid.

Bid security of not less than 2% of the bid price must be accompanied by **Financial Proposal** in sealed envelope, payable in the form of bank draft/pay order, drawn in favor of SBP Banking Services Corporation. **Conditional**, incomplete or bid(s) submitted without signed Bid Form by authorized nominee of the bidder will be rejected.
- 5. A Pre-bid meeting will be held on **July 27, 2015 at 1500 hours** at Learning Resource Centre, State Bank of Pakistan, Karachi.
- 6. The Bidders are requested to give their best and final prices as no negotiations are expected. The rates quoted must remain **valid for period of (120) days** after opening of bids.

Interested eligible bidders may obtain the bidding documents on submission of a written application on their firms' letter head to the address below upon payment of Rs.500/-(non-refundable) in the form of bank draft/pay order.
