 - d. The bidders should have verifiable presence/support/branch office in Karachi
 - e. Bidder must be registered with Income Tax and Sales Tax Departments.
- 4. Bidders will quote for COMPLETE REQUIREMENT, evaluation of bids and contract award will be done accordingly.
- 5. The Bidders are requested to give their best and final prices as no negotiations are expected. The rates quoted must remain valid for a period of one hundred twenty (120) days after opening of the bids.
- 6. All bids must be accompanied by a Bid Security of not less than 2% of the bid price. Bid found without / insufficient earnest money will be rejected. Late bids will be rejected. Bids submitted without signed Bid Form by authorized nominee of the bidder will also be rejected. Bid with material deviation exception, objection, conditionality, or reservation; shall also be rejected.
