- 1. Bidding will be conducted under National Competitive Bidding pursuant to "Single stage- single envelope procedure" as per Rule 36(a) of Public Procurement Rules 2004 (PPR-2004) and is open to all eligible Bidders as defined in the PPR 2004. that meet the following minimum eligibility/qualification criteria:
- a. Bidder must be Manufacturer/ authorized agent of the manufacturer for the required item in Pakistan.
- b. Bidder must have minimum three (05) years of experience in supplies of similar item to government/semi-government/ private company/department. The annual volume of sales for last five (05) years should be over PKR 3.0million.
- c. Bidder should have verifiable presence at Karachi, with ability to provide rapid/prompt support at SBP BSC-HOK.
- d. Bidders must be registered with Income Tax and Sales Tax Department.
- 2. Bid security of not less than 2% of the bid price must be accompanied by **Financial Proposal** in sealed envelope, payable in the form of bank draft/pay order, drawn in favour of SBP Banking Services Corporation. **Conditional**, incomplete, late submission or bid(s) submitted un-signed Bid Form by authorized nominee of the bidder will be rejected.
- 3. The Bidders are requested to give their best and final prices as no negotiations are expected. The rates quoted must remain **valid for a period of ninety (90) days** after opening of bids.

Interested eligible bidders may obtain the bidding documents on submission of a written application on their firms' letter head to the address below upon payment of Rs.600/-(non-refundable) in the of bank draft/pay order in favour of SBP BSC (Bank), Karachi from the address given below from **9:00 am to 5:30 pm**.
