Bidding will be conducted under National Competitive Bidding pursuant to “**Single Stage- two envelope procedure**” as per **Rule 36(b) of Public Procurement Rules 2004 (PPR-2004)** and is open to all eligible Bidders as defined in the PPR 2004. that meet the following minimum eligibility/qualification criteria:
 - a. *Bidder must be Manufacturer/ authorized agent of the manufacturer for the required item in Pakistan.*
 - b. *Bidder must have minimum five (05) years of experience in supplies of similar item to government/semi-government/ private company/department. The annual volume of sales for last five (05) years should be over PKR 5.0million.*
 - c. *Bidder should have verifiable presence at Karachi, with ability to provide rapid/prompt support at SBP BSC-HOK.*
 - d. *Bidders must be registered with Income Tax and Sales Tax Department.*
2. Bid security of not less than **2%** of the bid price must be accompanied by **Financial Proposal** in sealed envelope, payable in the form of bank draft/pay order, drawn in favour of SBP Banking Services Corporation. **Conditional**, incomplete, late submission or bid(s) submitted un-signed Bid Form by authorized nominee of the bidder will be rejected.
3. The Bidders are requested to give their best and final prices as no negotiations are expected. The rates quoted must remain **valid for a period of ninety (90) days** after opening of bids.
4. Interested eligible bidders may obtain the bidding documents on submission of a written application on their firms’ letter head to the address below upon payment of Rs.600/-(non-refundable) in the of bank draft/pay order in favour of SBP BSC (Bank), Karachi from the
